To that end, the DRNC supports with conditions CF 22-0932 and the continued study of the Scattergood Green Hydrogen project subject to the conditions raised by Councilmember Park in her January 23, 2023 letter to the Energy & Environment Committee, including but not limited to ensuring the safety of transportation and storage of hydrogen, assessing the environmental impacts, and verifying that the hydrogen is sourced from green resources. In addition the DRNC requests transparency to the public in assessing the costs of the project as it continues to be evaluated.
