 - a. Approval of Minutes from September 14th General Board Meeting
 - b. **Motion (Daniel Perez)** The DRNC approves the September 2023 Monthly Expenditure Report (MER).
 - c. Motion (Daniel Perez) The DRNC approves a \$1,000 NPG to the Boys & Girls Club of Santa Monica at Mar Vista Gardens to support the 10th annual Del Rey Cup soccer tournament.
 - d. Motion (WRAC/Ravi Sankaran) The DRNC requests that the LA City support the West LA/Sawtelle NC's request for a public park and skateboard facility as part of the West LA Commons project, that maintains high-density housing and numerous affordable units. This park would serve the 2,500 tenants of the project as well as the 5,000 neighbors who live to the south and do not have a park, and visitors from Westwood, Mar Vista, Bel Air-Beverly Crest and Brentwood who visit the Felicia Mahood Senior Center and the West LA Municipal Building.

- c. Motion (LUPC/Pooja Bhagat): The DRNC approves the proposed 6-story, 66-feet tall 4112-4136 Del Rey Avenue residential project consisting of 210 rental apartments on 253,954 SF subject to the following conditions of the applicant:
 - i. Confirm the street widening on Del Rey Avenue per the Glencoe Maxella Specific Plan
 - ii. Provide 10% affordable housing
 - iii. Provide for a new traffic signal at Del Rey/Maxella intersection to be synced with Lincoln/Maxella signal and designed for safe and efficient traffic flow
 - iv. Provide a traffic study
- d. Motion (Ravi Sankaran): The DRNC supports CF 23-0914 which calls for recommendations for a citywide program to designate streets where RVs/oversize vehicles can safely park with access to services, including housing navigation, portable restrooms, automotive repair and septic tank disposal. The program would also restrict RV parking in residential and other sensitive areas. Del Rey and other neighborhoods have been impacted by increased RV parking with lack of support services, especially near Bill Rosendahl Del Rey Park, which can in some cases result in illegal discharge of hazardous substances into storm drains and public rights-of-way, loss of parking for non-vehicle dwellers, reduced line-of-sight at intersections and driveways and other impacts. Therefore the DRNC supports CF 23-0914.
- e. **Motion (Ravi Sankaran):** The DRNC supports CF 23-1056 which seeks to create an e-bike purchase incentive program in the City similar to the programs that currently exist for electric cars. The most popular electric vehicles today are not cars but electric bikes, which outsold electric cars in 2021 and 2022. Using a tiny fraction of the energy and battery power that a car requires, these vehicles can be a true car replacement for many households. While there are many incentives for electric car purchases, there are currently no federal, state, or local incentives in Los Angeles that lower the cost of purchasing an e-bike. Programs in other cities, such as Denver, have been wildly popular and have helped people move to an e-bike for their daily errands thus reducing car miles traveled. Locally Santa Monica and Pasadena have adopted similar programs. Therefore the DRNC supports the development of an e-bike purchase incentive program in the City of Los Angeles.
- f. **Motion (Daniel Perez)**: The DRNC approves a \$1,500 NPG to the Pacific Area Boosters Association to support the purchase of a community emergency preparedness supplies shed at LAPD Pacific Division.
- g. **Motion (Daniel Perez)**: The DRNC approves a \$1,000 NPG to the HELPER Foundation to support the 9th annual Community Day.
- h. **Motion (Daniel Perez)**: The DRNC opposes the LA City Department of Recreation & Park's decision to create separate Park Advisory Boards for Culver Slauson Recreation Center and Bill Rosendahl Del Rey Park. The decision was made without sufficient community input, counters the DRNC's efforts to create a cohesive sense of community, and removes resources from our already-underserved communities in Areas G and E. The DRNC encourages the Department to reinstate a Park Advisory Board that represents and can support the work of both Culver Slauson Recreation Center and Del Rey Bill Rosendahl Park.
