 - **d.** Neighborhood Organization Representative- This Director is a Stakeholder who participate in a community-based organization, including but not limited to a religious institution, educational institution, non-profit organization, neighborhood association, school/parent group, faith-based group, senior group, youth group, arts association, service organization, boys or girls club, cultural group, or environmental group within the NC boundaries.
 - **e. District Two Seat-** *Lives, works, or owns real property within the boundaries of the neighborhood council; or is a Community Interest Stakeholder, defined as an individual who is a member of or participates in a Community Organization within the boundaries of the neighborhood council.*
 - f. District Three Seats (5 Seats)- Lives, works, or owns real property within the boundaries of the

neighborhood council; or Is a Community Interest Stakeholder, defined as an individual who is a member of or participates in a Community Organization within the boundaries of the neighborhood council.
