The GWNC shall make reasonable efforts to accommodate any member of the public that requests an accommodation to participate in the meeting, by providing a publicly accessible physical location for the member of the public to participate from, providing access to technology necessary to participate in the meeting, or identifying locations or resources available that could provide the member of the public with an opportunity to participate in the meeting.

To address the Board on any agenda item before the Board takes action on that item, the public is requested, when prompted by the chairperson, to dial *9 (if connecting by phone) or press the “raise hand” button (if using the Zoom app). Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the agenda but which are within the Board’s jurisdiction will be heard during the General Public Comment period. The Board is prevented from acting on a matter brought to its attention during the General Public Comment period; however, it may become the subject of a future Board meeting. Public comment is limited to two minutes per speaker, unless adjusted by the chairperson.

Public comment cannot be required to be submitted in advance of the meeting. Only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, or if members of the public are unable to provide public comment or be heard due to issues within the Greater Wilshire Neighborhood Council’s control, the meeting must be recessed or adjourned.

가상 회의 원격 회의 지침 / 주민회의 회의에서 대중의 의견 제시: 이사회/위원회에서 연설을 원하는 모든 사람은 (669) 900-6833 또는 (877) 853-5257로 전화하여 889 6098 2957를 입력한 다음 #을 눌러 회의에 참여해야 합니다. 의장이 지시할 때 대중은 *9(전화로 연결하는 경우)를 누르거나 "손들기" 버튼(Zoom 앱을 사용하는 경우)을 눌러 위원회에서 의제에 대해 연설하도록 요청받습니다. 위원회가 항목에 대한 조치를 취하기 전에 항목. 의제 항목에 대한 공개 의견은 해당 항목이 고려될 때만 청취됩니다. 의제에 나타나지 않고 이사회 관할권에 속하는 기타 문제에 대한 공개 의견은 일반 공개 의견 수렴 기간 동안 청취됩니다. 위원회는 일반 대중 논쟁 기간 동안 귀하가 위원회에 전달한 문제에 대해 조치를 취할 수 없습니다. 그러나 이는 향후 이사회 회의의 주제가 될 수 있습니다. 공개 의견은 의장이 조정하지 않는 한 발언자당 2분으로 제한됩니다.

GWNC는 대중이 참여할 수 있는 편의 시설을 요청하는 모든 대중을 수용하기 위해 대중이 참여할 수 있는 공개적으로 접근 가능한 물리적 장소를 제공하고, 회의에 참여하는 데 필요한 기술에 대한 접근을 제공함으로써 합당한 노력을 기울여야 합니다. 또는 일반 대중이 회의에 참여할 수 있는 기회를 제공할 수 있는 위치나 자원을 식별합니다.

공개 의견은 회의 전에 제출하도록 요구할 수 없으며 실시간 공개 의견만 제출하면 됩니다. 대중이 회의를 참관하거나 들을 수 없도록 방송이 중단되거나, 광역 Wilshire 주민 의회가 통제할 수 있는 문제로 인해 대중이 공개 논쟁을 하거나 들을 수 없는 경우, 회의는 다음과 같이 이루어져야 합니다. 정치 또는 연기되었습니다.
