- 9. Discuss and possible motion to request a left turn signal be placed on the intersection of Del Amo and Western Avenue. This location has been a problem for several years.

Discuss and possible motion to request a CalTrans Traffic Study for a streetlight to be placed on the intersection of Carson Street and Halldale Avenue for the safety of students attending Halldale Elementary School. This is a high traffic area on a busy major street and Halldale Elementary is one block away. There has been concern from parents as to the safety of students crossing the street.
- 11. Discuss outreach method to get the community input on areas needing Traffic Study for cross walks, stop signs, and traffic lights.
- 12. Discuss LAPD lack of Deployment in the Harbor Gateway and the process to address the issue.
- **13. Motion to appoint a Financial Officer as 2nd Cardholder** requirements: complete funding training for Financial Officers (this is in addition to regular funding training). The 2nd Cardholder will be issued a purchase card from the City of Los Angeles and would be responsible for payment of board approved expenditures using the purchase card, will obtain receipts for transactions and upload to the City Funding Dashboard Portal.

Comments from the public on agenda items will be heard only when the respective item is being considered.

Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to 2 minutes per speaker, unless adjusted by the presiding officer of the Board.

AB 361 Updates: Public comment cannot be required to be submitted in advance of the meeting, only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned.
