 - Seats to be filled:
 - a. Member at Large Open to stakeholders, except Community Interest Stakeholders, at least eighteen (18) years of age at the time of election or appointment.
 - b. Member at Large Open to all stakeholders at least eighteen (18) years of age at the time of election or appointment.
