Rodriguez; The city is required to adopt an Urban Water Mangement Plan (UWMP) every five years to comply with California's Urban Water Management Planning Act. The 2020 UWMP is the last adopted plan and continues to serve as the City's master plan for reliable water supply and resources management. With a 25-year planning horizon through the year 2045, the 2020 UWMP included a strategy to achieve the City's goals and policy objectives for reliable water supply. The strategy included the development of additional local supplies to help reduce the City's future dependence on purchased imported supplies, supported by recommendations from prior program level planning initiatives
