#### SB 411 Updates:

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the callin option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

(C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.

(D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.

(E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph (D), to provide public comment until that timed public comment period has elapsed.

(ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.

(iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

**Clarification on our by-laws re**: We do not count abstentions. Abstentions are counted as yes votes. We follow the policy of the City Council.

c. MAYOR'S PROPOSED BUDGET CUTS: CF# 25-0600 – Discussion by board and stakeholders regarding the Budget Proposal cuts impacting NCs as well cuts to personnel in many if not most city departments including DONE (Empower LA). NC CIS's and individual letter submission deadlines is May 30th.

### Possible motions include:

**POSSIBLE MOTION #1 (CIS to be submitted to CF#25-0600):** HHWNC supports/does not support the proposed Budget cuts to Neighborhood Councils annual funding from a base of \$32,000 to \$25,000. (**POSSIBLE DISCUSSION AND VOTE**).

**OPPOSITION ARGUMENT:** On formation of the NC System, Budgets were originally set at \$50,000 per fiscal year. Cuts on NC budgets have been implemented throughout the NC's history without ever being fully restored. Board members personally absorb many out-of-pocket costs for materials and equipment including cell phones, computers, printers, not to mention hundreds of thousands of hours of volunteer time. Any attempt at reimbursement of out-of-pocket expenses is complicated and antiquated requiring a full board vote technically in advance of the expense which in most cases is impossible.

**SUPPORT ARGUMENT:** HHWNC is very careful with its budget and saves these tax-payer funds by donating hundreds of hours as elected but unpaid members of the board every year. HHWNC funds are used to support 501c3 projects and/or events that provide benefits to our community stakeholders, as well as to do Outreach to our community to encourage more stakeholder participation, and for our city approved administrative vendor on retainer to oversee IT, email, website, etc. issues. When possible, we try to have funds to rollover to the next fiscal year to support more projects.

**MOTION #2**: HHWNC pays tribute to our DONE Project Manager, NEA Dina Andrews, due to her extensive knowledge, and limitless dedication to our Board as well as our Stakeholder Community. The Board requests that the Mayor and DONE Senior Management protect Ms. Andrews employment and that under no circumstances she be considered for termination due to the current budget cuts proposed by the Mayor. Ms. Andrews has been essential to maintaining the strength and functionality of our board as well as many others. She is an invaluable contributor to our meetings and has been available to each of our board members

and officers for advice, consultation on various issues and guidance through situations on all levels of concern. (POSSIBLE DISCUSSION AND VOTE).

### b. Parks & Open Spaces Chair, Graham Rossmore

### 1. Report re: Joint Meeting with Areas 3, 4, 5 & 7 held on April 9, 2025

Dorothy J. and Benjamin B. Smith Park is a small, rectangular pocket park on the south side of Franklin Avenue (CD 13) between Sycamore Avenue and Orange Drive.

In 2020 the City purchased the Highland Gardens Motel, located across from the park, on the north side of Franklin Avenue (CD 4). Since then, Highland Gardens Motel has operated as the only City-owned and operated temporary/interim housing for Angelenos experiencing homelessness within HHWNC's boundaries.

As a result, the park, across the street, has served as a hotspot for illegal activity, including encampments, public intoxication, open air drug use, graffiti/vandalism, public indecency, and other behavior that has severely impacted the neighborhood's perception of safety and ability to use this park.

Council Districts 13 and 4, and the Department of Recreation and Parks (RAP) are now seeking to reactivate and rehabilitate the park by exploring alternative uses, like a neighborhood dog park, and permanent fencing with nightly locked gates. The joint committee chairs voted unanimously to propose the following motion to the HHWNC Board

**MOTION:** HHWNC supports the unanimous decision of the JOINT Committees including Parks & Open Spaces, Areas 3, 4, 5 & 7 to recommend to CD4 and CD13 that a partial area of Dorothy and Benjamin Smith Park located on the South Side of Franklin Avenue between Sycamore Avenue and Orange Drive be transitioned to a Neighborhood Dog Park.



### From Senior Lead Officer Joseph Raviol to HHWNC Public Safety Chair- May 14, 2025

Good Afternoon Paul,

I wanted to advise you of an ongoing criminal activity that has been a hot topic in the Hollywood Hills the past several months.

Vacant properties have been the target of squatters. Squatters are people that unlawfully occupy an uninhabited building or unused land. <u>Often times</u> vacant properties that appear to be left abandoned with overgrown landscaping, and an unkept appearance attract people who will hide under the guise being at a location for maintenance, or contract work. They can provide easily accessible owner information to questioning neighbors or <u>police</u>, and are known to provide mail or paperwork with their name on it to distract from the fact that they are unlawfully occupying the real estate.

I encourage every person who often travels, or who owns a property that is unoccupied for more than a few days to complete a "Trespass Authorization Form". This form is extremely important because if an officer responds to a radio call for a trespass investigation, and they come across a person who claims to live at a location, but the reporting person or neighbors say different, then the officers can contact the Watch Commander's Office and check to see if the person at the location has legal authority over the property.

The form is completed <u>yearly, and</u> has to be notarized or signed by a police officer in order to be valid. In cases where a form is completed, and the community member wants me to sign the document, I will retrieve the document in person to verify they own/ reside at the property listed on the form.

The law for trespassing states that a trespasser has to be warned. In the event that a trespasser is a squatter, and the form is on file, officers can make contact with the person listed on the form and verify if the suspect is legally at the location.

There have been recent cases in the Hollywood Hills where an individual has squatted in a residence, and established residence for over a month before the owner of the property has found out. The owner of the property had to go through an eviction process, and the squatter continued living in the residence for approximately one year.

This same squatter would even attempt to take over other vacant house and posts his activities on social media. He would then encourage other people to do as he does and attempt to take over properties.

Hollywood Heritage is asking for a NPG grant to install emergency "panic" hardware on the gated entrances to the Hollywood Heritage Museum. This will enhance public safety as well as security at this significant and vulnerable site. The Lasky DeMille Barn is one of the oldest buildings in Hollywood. Rented by Cecil B. The public purpose and benefit is that the purchase of the equipment and installation will protect this major public historic and cultural asset in HHW, as well as all who visit and work there for decades to come.

This letter is in response to your telephone inquiry for a copy of your organization's determination letter. This letter will take the place of the copy you requested.

Our records indicate that a determination letter issued in July 1980, granted your organization exemption from federal income tax under section 501(a)(3) of the Internal Revenue Code. That letter is still in effect.

Based on information subsequently submitted, we classified your organization as one that is not a private foundation within the meaning of section 509(a) of the Code bacause it is an organization described in section 509(a)(2).

This classification was based on the assumption that your organization's operations would continue as stated in the application. If your organization's sources of support, or its character, method of operations, or purposes have changed, please let us know so we can consider the effect of the change on the exempt status and foundation status of your organization.

Your organization is required to file Form 990, Return of Organization Exempt from income Tax, only if its gross receipts each year are normally more than \$25,000. If a return is required, it must be filed by the 15th day of the fifth month after the end of the organization's annual accounting period. The law imposes a penalty of \$20 a day, up to a maximum of \$10,000, when a return is filed late, unless there is reasonable cause for the delay.

All exampt organizations (unless specifically excluded) are liable for taxes under the Federal Insurance Contributions Act (actiel security taxes) on remuneration of \$100 or more paid to each employee during a calendar year. Your organization is not liable for the tax imposed under the Federal Unemployment Tax Act (FUTA).

Organizations that are not private foundations are not subject to the excise taxes under Chapter 42 of the Code. However, these organizations are not automatically exempt from other federal excise taxes.

Donors may deduct contributions to your organization as provided in section 170 of the Code. Bequests, legacies, devises, transfers, or gifts to your organization or for its use are deductible for federal estate and gift tax purposes if they meet the applicable provisions of sections 2055, 2108, and 2522 of the Code.
