- 7. Discussion and possible motion to appoint an East Region Director to the vacant seat. The 2022 LA32NC Bylaws provide: "The order of selection of Directors is as follows:
 A. Runners-up for Same Region – The Board first nominates from the pool of candidates in the same Region who did not win a seat in the previous election, but who are still interested in serving;
 B. Top Runners-up for Any Other Region – If there were no losing candidates from the same Region, the Board nominates from the top runner-up candidates from other categories (Region or At-Large);
 C. Nominated Stakeholders – Directors may nominate Stakeholders, or any Stakeholder can request consideration for filling a vacancy; and D. Board Approval – The Board votes and approves all nominations to fill vacancies by a simple majority vote. The Director selected in this way will serve out the remainder of the original term."
