ASSEMBLY BILL 361 (RIVAS) AND DUE TO CONCERNS OVER COVID-19, THE LA32
NEIGHBORHOOD COUNCIL MEETING WILL BE CONDUCTED ENTIRELY WITH A CALL-IN

AB 361 Updates: Public comment cannot be required to be submitted in advance of the meeting; only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned.

B. Top Runners-up for Any Other Region – If there were no losing candidates from the same Region, the Board nominates from the top runner-up candidates from other categories (Region or At-Large);
C. Nominated Stakeholders – Directors may nominate Stakeholders, or any Stakeholder can request consideration for filling a vacancy; and **D.** Board Approval – The Board votes and approves all nominations to fill vacancies by a simple majority vote. The Director selected in this way will serve out the remainder of the original term.”
