**Description:** The Project proposes the demolition of an existing office building and the development of a new mixed-use building containing 77 new apartment units, including 8 affordable units, and of street level commercial space. The Project would utilize Transit Oriented Communities Base Incentives for increase in density, increased floor area, and reduced parking. In addition, the Project will require a site-specific Zoning Administrator Interpretation for relief from transitional height requirements due to proximity to an Open Space Zone in the median of San Vicente Boulevard.

**Requested Motion**: Discuss and take potential action to approve applicant's request related to TOC Base Incentives; Zoning Administrator Interpretation for relief from transitional height requirements outreach for stakeholders and condition approvals of at least 20% for workforce development. The Committee voted at its May meeting: 4 Yays; 0 Nay; 0 Abstention. The Motion passed.
