  - "LADWP Shared Solar Program: two initiatives that help Angelenos save on utilities.
  - We are launching this survey to help inform our program development for future workshop series and campaigns that center our communities' interest for example, understanding utility bills or adding more green space to our neighborhoods. The survey is only 5-6 minutes long and by completing it everyone is entered in our raffle to win a \$50 Target gift card or 1 of 2 \$25 Target gift cards.
  - In addition, we've teamed up with LADWP to get the word out about the Shared Solar Program, which allows for renters in multi-residential housing to gain access to renewable energy without facing all of the barriers that occur when trying to go solar. It provides renters with relief by getting ahead of the rising costs of utilities by replacing a portion of their electricity usage with renewable energy. LADWP's rates are projected to go up 30% so we think this program can help your neighbors!
  - We would love to have the opportunity to work together with your board on getting
    the word out about LADWP's Shared Solar Program, whether it is doing a
    presentation for your members or even setting up a table at one of your events.
    With a large portion of Angelenos being renters living in multi-residential housing,
    it's important that they know they can and deserve to have access to renewable
    energy"
