  - 1) Consider CIS and a resolution to support Council File #22-0002-S82, California State Senate Bill SB-1122 and Assembly Bill AB-2897, which seek to expand the territory of the Rivers and Mountains Conservancy to include the hydrologic basin or watershed that coincides with the Dominguez Channel bounded by Manchester Boulevard in the City of Inglewood to the north, and the Los Angeles and Long Beach Harbors, as well as Santa Catalina Island, including the City of Avalon, and unincorporated areas on the island in the Conservancy's territory.
  - 2) Consider CIS and a resolution to support Council File #22-0255 Green Hydrogen Hub to support the Green Hydrogen Hub Capital Improvement Project with the caveat that certain concerns are addressed. The federal government is seeking candidates for \$8 billion dollars in federal grants to create hydrogen fuel hubs. Four cities will be chosen. The LA City Council approved a motion directing the Port of Los Angeles, DWP, and other partners and agencies to develop and submit a proposal to the US Department of Energy to consider Los Angeles as a candidate.
