Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period.

AB 361 Updates:

- Public comment cannot be required to be submitted in advance of the meeting; only real-time public comment is required.
- If there are any broadcasting interruptions that prevent the general public from observing or hearing the meeting, the meeting must be recessed or adjourned.
- If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned.

If you are calling in by phone, you need to press *9 to speak. If you used the webinar number to log in, you will use raise hand feature to speak and be called on. If you don't see a raised hand, hit ESC and go from full screen to see raise hand option.

During the meeting tonight, we will discuss the items listed on the meeting agenda in numerical order. There will be public comment period for 10 minutes after each agenda item, with a maximum of 1 minute per speaker. If you want to make public comment and you are attending by computer, click the "raise hand" option in the Zoom window. If you are attending by phone, you will need to press star (*) 9 on your dial pad.

For Public Comment, when it is the member of the public's turn to speak, the timekeeper will announce either the last 4 digits of the telephone number or state the person's name as indicated on the Zoom participant list. The timekeeper will unmute the speaker and ask that they state their name for the record and proceed with their comment. When the time has expired, the timekeeper will mute the speaker and advise their time for comment has concluded.

In general comment at end of the forum, you may provide your comment during the "General Public Comments" portion of the meeting. General Public Comment is limited to 1 minute maximum, once per person until everyone has had a chance to comment. Additional opportunities may be available at moderator's discretion until 9 pm.
