## d. Discussion of Phillips 66 Notice of Preparation for an EIR to support its application for a 40year lease on its marine oil terminal in the Port

- 1) Phillips primary purpose for the project is to upgrade the docks to comply with California's MOTEMS safety requirements. Although Phillips and its predecessors have been occupying the terminal on a thirty-day month-to-month permit since 1990, they insist that a long-term lease is needed to justify incurring the costs. The 45-day review period closes April 10. There was a public zoom meeting to elicit comments on March 14.
