- 0:00 13. **Discussion and possible action on the proposal that the Panorama City Neighborhood Council support and participate in an online Alzheimer's Association Community Forum in Fall 2026, which may be coordinated by the Valley Alliance of Neighborhood Councils.** This is an expression of interest in supporting a program for older Angelenos and is not a proposal for a council-sponsored or co-sponsored event.
- 0:00 14. **Discussion and possible action on the approval of the purchase card expenditure of \$10.96 by Board Treasurer John DiGregorio for a new lock and two keys that he decided to purchase for the council's storage unit.**
- 0:00 15. **Discussion and possible action on the request of Treasurer John DiGregorio for approval of a proposed Inventory Control Policy which requires anyone who need access to the storage unit to request access in writing at least 36 hours before the event to both the Treasurer and the Outreach Chair, including the following information: 1. Your name and board role, 2. The event name, date, and location. 3. A list of the specific items you are requesting. 4. Your preferred pickup date and time. It states that requests that do not meet the 36-hour minimum notice requirement may be denied. The policy also includes extensive Sign-Out and Return Procedures, including detailed written lists of items removed with their condition as well as lists of items returned with their condition.**
There have been some concerns expressed regarding the need for the extensive proposed protocol which contrasts with the informal access controls that have been used by the council in prior years.
- 0:00 16. **Discussion and possible action on the need to prepare a formal inventory of city property held by the council. The city requires that all electronic items be listed with model and serial number and that all items on hand be photographed. The inventory needs to be done on the City Clerk's official spreadsheet and the inventory needs to be reconciled with the last inventory on hand from the City Clerk.** Once this inventory is completed, the Board can consider what items might be declared surplus or obsolete. Surplus items must be returned to the city facilities warehouse in downtown Los Angeles, the C. Erwin Piper Technical Center ("Piper Tech"), 555 Ramirez Street, just East of Union Station.

Meetings of this committee would be conducted in Spanish with a Spanish-English interpreter.** This committee might also partially fill the void that will be left by the decision of First 5 Los Angeles (the county's tobacco tax for kids organization) to stop funding all "Best Start" communities in Los Angeles County. Best Start Panorama City and Neighbors has been operating for over a decade and has provided online meetings and local events to connect young families with services and activities.

TELECOMMUNICATIONS MEETING INSTRUCTIONS AND PUBLIC COMMENT

In conformity with the January 1, 2026 enactment of California Senate Bill 707 (Durazo) and LA City Council file 23-1114, Neighborhood Council meetings may be conducted virtually if the Board takes action to choose this option for its meetings.

Every person wishing to address the Board must dial the Zoom dial-in number listed in the agenda title and enter the Zoom meeting ID number listed in the agenda title and then press # to join the meeting. When prompted by the presiding officer, to provide public input at the Neighborhood Council meeting the public will be requested to dial *9 if on telephone or use the Raise Hand option in an online Zoom meeting to address the Board on any agenda item before the Board takes an action on an item. Comments from the public on agenda items will be heard only when the respective item is being considered.

Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to ____ minutes per speaker, unless adjusted by the presiding officer of the Board.

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1. California Government Code Section 54953.8(b)(3).

The legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time. California Government Code Section 54953.8(b)(4).

Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate. California Government Code Section 54953.8(b)(5),

A legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to paragraph (5), to provide public comment until that timed public comment period has elapsed.
California Government Code Section 54953.8(b)(6)(A),

A legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to paragraph (5), or otherwise be recognized for the purpose of providing public comment.
California Government Code Section 54953.8(b)(6)(B).

Council Process: The council gained its official city role upon certification by the Board of Neighborhood Commissioners on March 15, 2007. Everyone who lives, works or owns real property within the boundaries of the Panorama City Neighborhood Council, or who declares a Community Interest in the area and the basis for it, is a "stakeholder". All stakeholders are members of the Council. Stakeholders elect a Board of Directors to represent them. This Board is recognized as the decision-making entity by the City of Los Angeles. The current Board was elected in Spring, 2025. The next election is planned for Spring, 2027. While the Board is the official decision-making entity, meetings are conducted as much as possible in a town hall spirit. Committees are open to anyone with an interest in Panorama City. Panorama City's neighborhood council is much more than its Board, and it depends on public participation for its success.

Posting Sites: California's open meetings law, the Ralph M. Brown Act, requires that meeting notices be physically posted at a regular location 72 hours in advance for regular meetings and 24 hours in advance for special meetings. The location must be accessible to the public seven days a week, 24 hours a day. That location is the outside windows or steel doors of the Plaza Del Valle Community Room, Building G, 8700 Van Nuys Boulevard, Panorama City, CA 91402. This council is also required to follow the City of Los Angeles posting policy for Neighborhood Councils. That policy additionally requires that councils post agendas through the city's Early Notification System (ENS), post the agendas on the council's website (if one exists), and make an effort to send agendas by electronic mail (if such a list exists). This council posts agendas on its website, panoramacitync.org. This council uses the city's ENS mailing list as its agenda email list. You may sign up for the ENS agenda system at:

In addition to the Plaza Del Valle posting location, this council MAY post agendas at other locations within Panorama City. These may include: (1) Panorama City Branch Library, 14345 Roscoe Boulevard; (2) Panorama Recreation Center, 8600 Hazeltine Avenue; (3) Sepulveda Recreation Center, 8801 Kester Avenue; and (4) Casa Esperanza, 14705 Blythe Street. In addition to the ENS agenda list, this council MAY include agendas in its occasional informational emails. You can subscribe to the council's informational email list by sending your request to 'info@panoramacitync.org'. You can also sign up on the council's website. In order to respect our stakeholders' inboxes, messages to the informational email list will be sent at most once or twice a month. *The only way to assure that you will receive emailed agendas is through the ENS list.*
