Every person wishing to address the Board must dial 669.900.6833, and enter 851 6123 2288 and then press # to join the meeting. When prompted by the presiding officer, to provide public input at the Neighborhood Council meeting the public will be requested to dial *9 or use the Raise Hand option, to address the Board on any agenda item before the Board takes an action on an item. Comments from the public on agenda items will be heard only when the respective item is being considered.

Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to two minutes per speaker, unless adjusted by the presiding officer of the Board.

SB 411 Updates:

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

(C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.

(D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.

(E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph (D), to provide public comment until that timed public comment period has elapsed.

(ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity

to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.

(iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

 - Agendize for the January 21, 2025 General Board meeting board action to recommend one board member to serve as a panelist to sit on a Regional Grievance Panel. A training for regional grievance panelists will be held in partnership with the Office of City Attorney Dispute Resolution Program.  - 2. Agendize for discussion and possible action at the January 21, 2025 General Board meeting follow-up to the Central LA virtual community workshop to develop a community-driven action plan to improve walking and biking safety focusing on neighborhood schools of Commonwealth Avenue ES, Frank Del Olmo, and Lafayette Park PC. At LA Metro's presentation at our July 16 General Board meeting on the Vermont Transit Corridor Project, Philip asked Metro to consider a scramble crosswalk at 3rd Street and Vermont Avenue in their planning for the Bus Rapid Transit which has a proposed station at that intersection. On November 20, Neha Chawla, Senior Manager, Metro Transportation Planning, informed us that: 1) the MAT Program can only fund capital projects, so a study would not be eligible; 2) Metro will, however, be developing a First/Last Mile Plan for the Vermont Transit Corridor Project; and the area of 3rd Street and Vermont Avenue may be assessed for proposed improvements/projects; and 3) they are currently developing Metro's Street Safety Program, and this corridor may be included in their data assessments.
 - 3. Discussion and possible action regarding concerns raised by Carolyn Burleson about the existing conditions of the 100 block of S. Occidental Boulevard. At our community cleanup of the Occidental Parkways on December 7 with Councilmembers Hugo Soto-Martinez and Eunisses Hernandez, we observed a need for green infrastructure improvements there. Diana Vicente, CD 1 Field Deputy, informed us at the time that she is looking for grant funding to replant those parkways. CD 1 is also looking at options for planting native plants in the Occidental Parkways and maintaining them since the climate fellows are no longer available. Javier Solis, Superintendent of Recreation and Parks Maintenance Operations, 213-485-4809, informed us that the Occidental Parkways belong to Public Works/Bureau of Street Services/Urban Forestry Landscape Division.  - 4. Discussion and possible action to agendize for the January 21 General Board meeting to address resumption of PATH Neighborhood Watch Committee meetings. We've invited Zeke Sandoval of PATH to our PSHT Committee meeting. In the meantime, Jennifer is attending the Community Police Advisory Board for the LAPD Rampart Division as the RVNC's liaison.

- 5. Discussion and possible action to agendize for the January 21 General Board meeting to APPROVE the November 2024 Monthly Expenditure Report.
- 6. Discussion and possible action to agendize for the January 21 General Board meeting to consider approving the authorization of reimbursement of an already approved purchase of \$467.57 for a hand-held wireless system microphone. When he bought the microphone, Ronee said the credit card was rejected.
- 7. Discussion and possible action to agendize for the January 21 General Board meeting a report regarding the implementation and results of incorporating Spanish translation at RVNC general board meetings over the last 6 months. The report should include the efforts made by the CROSN Committee and each board member to outreach to our majority Spanish-speaking stakeholders, the costs of interpretation (\$279 per meeting), and the number of stakeholders that have utilized said translation services (one person told us they were trying to get into the Spanish room).
- 8. Discussion and possible action to agendize for the January 21 General Board meeting a proposed letter of support to the City Council requesting that they pass a motion to recommend to the California DMV to provide Bengali language translation of examination questions for the driving test and learner's permit test. Shafi will provide a draft of the proposed letter of support.
- 9. Discussion and possible action to agendize for the January 21 General Board meeting to nominate and approve the selection of any applicants to the Parks, Planning, Public Works and Land Use (PPPWLU) Committee. Hector and Gaines have been asked to reach out to the three most recent applicants to the PPPWLU Committee as their applications have to be approved by the board.
- 10. Discussion and possible action to agendize for the January 21 General Board meeting to approve an announcement to inform any stakeholders who are interested in running for an RVNC board seat to complete a candidate filing application online using the <u>NC Portal</u> or complete and download a fillable paper application <u>here</u>. The candidate filing deadline for the RVNC is Monday, **February 10, 2025**, at 11:59 p.m. Additional candidate filing resources are available at <u>clerk.lacity.gov/nccandidate</u>. - 11. As recommended by the Public Safety, Housing & Transportation Committee, discussion and possible action to agendize for the January 21 General Board meeting a presentation for and consideration of supporting the Bimini Plaza People Street Plan. This plan was approved by the City Council Transportation Committee and the full City Council in December, and Lois was informed by the LADOT Project Manager that LAEVI's People Street Plaza--IN THE MAKING FOR THE PAST 12 YEARS-- will begin installation in mid-January.
- 12. As recommended by the Public Safety, Housing & Transportation Committee, discussion and possible action to agendize for the January 21 General Board meeting consideration of and possible action on the matter of a pedestrian throughway at 200 N Vermont Avenue. On November 20, Jane Choi, Principal City Planner, Central Project Planning at LA City Planning, told us they are happy to look into this issue for us. It may take a couple of weeks for her to get back to us. In a November 22 call, David Burkhead, Senior Building Inspector at LADBS, explained that: 1) the 200 N Vermont Avenue project has a temporary certificate of occupancy (issued 7/31/24) to move tenants in; 2) because they don't have a certificate of occupancy issued, it's still an open permit which allows him to conduct an inspection and issue a notice of correction to remove the gate or return to Plan Check to address the issue; and 3) the inspection results will show up under the Permit Application Status History on the LADBS.org website. On January 9, Danalynn Dominguez, Central Project Planning, told us: As conditioned under Case No. DIR-2019-848-TOC-SPPA-SPP-SPR, the Applicant is required to provide a pedestrian throughway accessible to the public and have a minimum vertical clearance of 12 feet and a minimum horizontal clearance of 10 feet. The intent behind the regulation is to allow for better pedestrian circulation through the project site when the building occupies at least 250 feet of street frontage.
- 13. As recommended by the Public Safety, Housing & Transportation Committee, discussion and possible action to agendize for the January 21 General Board meeting to address the assault on November 8 of a student and a community member at Bimini Place and Whitehouse Place. At our November 19 General Board meeting, Kylie Jansen of CD 13 said she would send an email to Mike, Laila, and herself asking them to help facilitate a conversation with LAUSD and/or the LAUSD Board of Education. They would have some more ideas about what would be possible in terms of their office helping us secure that space and definitely open to ideas for activating. Kylie said she will bring up to Laila as well the possibility of getting a crossing guard at that location.
- 14. As recommended by the Public Safety, Housing & Transportation Committee, discussion and possible action to agendize for the January 21 General Board meeting the HCID rollout of a database of all low-income housing created in projects using Density Bonus or Transit Oriented Communities (TOC) incentives, including consideration of approving another community impact statement for Council File 23-0426, Affordable Housing / Multilingual Online System / Search and Application. On July 2, Emma Howard, CD 13 planning deputy, told us she would follow up with LAHD and LADBS on this issue in depth. On August 21, she told us the context is the affordable housing registry motion: <u>Council File 23-0426</u>, their colleagues at CD 4 are lead on this effort and she believes that the city is in process in terms of hiring the team that will create the system. Also, she notes that the

Housing Element Update would include some registry requirements as part of the <u>Resident Protections</u> <u>Ordinance</u>. At our September 17 General Board meeting, we passed a motion to approve a community impact statement for this council file. On January 7, Marites Cunanan in LAHD informed us: Upon careful consideration of the issues we addressed, LAHD will start adding the Contract Number/Agreement Number on LAHD's clearance for each affordable housing covenant recorded from January 1, 2025. This will help reconcile addresses and APNs. This addresses being able to match up permits with covenants for the future. In regard to the past, on November 9, Philip attended the monthly PlanCheckNC meeting and connected with Saad Tariq. Mr. Tariq informed Philip that although permit data itself is not available as a standalone layer in their <u>new Atlas</u> <u>database</u>, they will overlay the <u>Controller's covenant layer</u> with LADBS' address and parcel layers. This approach will allow users to identify parcels associated with the covenant layer, and from there, related permit information can be researched manually based on the identified location. - 15. Discussion and possible action to agendize for the January 21 General Board meeting to approve a project update on Purdue University's study of the risks associated with concrete buildings in Los Angeles constructed prior to modern seismic building codes. At our September 17 General Board meeting, we passed a motion to participate in the research study with the caveats that the RVNC acts as a conduit and does not take a major role or take the lead for hosting the workshop. Purdue University wants us to help them organize a community workshop at Rampart Village where they have identified a high density of concrete buildings constructed prior to modern seismic building codes. The project goal is to understand:
 - the value of retrofits that would allow buildings to be immediately reoccupied and minimize disruptions to public services after a major earthquake;
 - how these benefits vary depending on the building's function, like whether the building is residential, an
 office, a school or a grocery store;
 - how people interact with structures, and the impacts a community would experience if different buildings were damaged in an earthquake; and
 - how seismic retrofits should be evaluated and prioritized to develop guidance for public officials.
 On November 5, Philip spoke to Sandra Bonneville who said she just met with Dr. Johnson and the plan is to do not community workshops but survey style meetings and to schedule them in conjunction with their food distribution on Thursdays in January 2025. During her report under Item IV.B at the November 19 General Board meeting, Sandra Bonneville said she spoke to Dr. Johnson recently. On a Thursday in mid-January 2025, the research team will come on site to do the surveys during CCNP's food distribution.
- 16. Discussion and possible action to agendize for the January 21 General Board meeting to approve how we will incorporate Spanish interpretation into our board meeting set up and take down, including inviting guests, include in outreach how Spanish interpretation will be provided for the January 21 and subsequent General Board meetings), translating and printing the agenda and minutes (and taking the minutes) and other documents, sound system, video system, Zoom and recording (including recordings in English and Spanish), and ordering and picking up food and beverages. Along with sending them their regular invitations to attend the board meetings, we are asking our council district offices to distribute our agendas in Spanish and to explain to their subscriber lists that we have Spanish interpretation.
- 17. As recommended by the PSHT Committee, discussion and possible action to agendize for the January 21 General Board meeting: 1) to follow up on the updated project briefing by LA Metro on November 19 for the Vermont Transit Corridor Project; and 2) to approve another letter to LA Metro. On October 10, the RVNC sent a Letter of Support to LA Metro in which we also asked for a contact for the Metro Active Transportation Cycle 2 and whether a Metro bus/bike collision on July 30 was reported to LAPD. At our November 19 General Board meeting, Transportation Planning Manager Annelle Albarra reported that: 1) the 204 bus operator did not report the July 30 collision to Metro Operations; 2) whether there is a Metro policy that collisions of this kind have to be reported to LAPD would have to be a policy of Metro Operations; and 3) she will follow up to see if a response has been prepared to our letter to Stephanie Wiggins and follow up with that. The data gap for reporting to LAPD a collision between a Metro bus and a bicyclist raises question about the safety for bicyclists of shared bus and bike lanes planned on Vermont Avenue. In discussion at the December 4 PSHT Committee meeting, Philip stated that we have information provided by LA Metro at our November 19 General Board meeting to indicate that Metro does not track the data for bus/bicycle collisions such that the frequency and severity of these collisions on the Vermont Transit Corridor is unknown. In addition, on November 20, Neha Chawla, Senior Manager, Metro Transportation Planning, informed us that: 1) the MAT Program can only fund capital projects, so a study would not be eligible; 2) Metro will, however, be developing a First/Last Mile Plan for the Vermont Transit Corridor Project, and that area may be assessed for proposed improvements/projects; and 3) they are currently developing Metro's Street Safety Program, and this corridor may be included in their data assessments.
- 18. Discussion and possible action to agendize for the January 21 General Board meeting to focus our attention on getting street trees replanted in the 545 vacant street tree wells in the Rampart Village and identifying neighbors to maintain them. 19. Discussion and possible action to agendize for the January 21 General Board meeting to review and implement our plans for follow up to the CERT training for the RVNC. At our May 21 General Board meeting, we passed a motion to support the LAFDCERT Battalion 11 Coordinator in organizing a Neighborhood Team. Mr. Ababao provided the names of our CERT training graduates to the Neighborhood Team Program (NTP) through Patrick Botz-Forbes. We are still anticipating that Mr. Ababao will help us to recruit and train a Team Leader to help our NC to develop our Emergency Plan and build our Neighborhood Team. To request the six NTP training classes, the LAFDCERT Battalion 11 Coordinator recommended that we email Patrick Botz-Forbes and Chin Thammasaengsri and they told Philip on November 20 that they will get back to us. - 20. As recommended by the PSHT Committee, discussion and possible action to agendize for the January 21 General Board meeting the ongoing renovations at Shatto Park. On November 25, Ana shared with us the information she received from Anna Apostolos at LANI about the 2019 community visioning exercises, including the two community meetings held on June 22 and July 13, 2019. Based on that information, the RVNC asked Alan Antonio of CD 10 for support regarding: 1) getting picnic benches and tables installed under the trees next to the basketball court; and 2) improving planting/landscaping in front of the tennis courts to stop encampments there. - 21. As recommended by the PSHT Committee, discussion and possible action to recommend approval of a community impact statement regarding Council File 23-1134, Economic Roundtable / Economic Study / Annual Rent Increase / Rent Stabilization Ordinance (RSO) / Sole-Source Contract. According to a September 21 email from Councilmember Hugo, this motion called for an independent study of our rent control policies in LA so we can make changes to help working Angelenos. Recently, the Economic Roundtable released their independent report, highlighting how, for decades, LA's rent control policies have favored landlords at the expense of working families. CD 13 says they support a policy proposal from tenants [Editor's note: if you look at the link, the proposal is from tenant advocates, including Beverly-Vermont Community Land Trust] aimed at creating a more balanced policy for renters while still allowing landlords to turn a profit. Stay tuned: In the coming weeks, the Housing Department will present their report to City Council, where the Housing & Homelessness Committee will recommend exact policies for the full City Council to vote on.
- 22. As recommended by the PSHT Committee, discussion and possible action to agendize for the January 21 General Board meeting to approve a community impact statement regarding the draft ordinance and design guidelines or clarifications to implement Measure HLA. This community impact statement will address three council files related to implementation of Measure HLA: Council File <u>15-0719-S26</u>, Council File <u>24-0131</u>, and Council File <u>24-0173</u>. Council File 15-0719-S26 began as an effort to pre-empt the proposed Healthy Streets LA Ballot Measure and has evolved with the passage of Measure HLA into the proposed mechanism to allow City Departments to implement Measure HLA. Council File 24-0131 requests a list of corridors that would necessitate the removal of parking spaces and vehicle travel lanes to implement Measure HLA. Council File 24-0173 advocates a three-prong implementation approach for Measure HLA: 1) Adopting a City implementation ordinance to clarify decision-making processes, promote thoughtful project planning, and minimize legal exposure related to noncompliance with the Measure's requirements; 2) Aggressively pursuing the development of a 5-year Capital Infrastructure Plan (CIP) to better align resources with projects that would achieve the City's policy goals; and 3) Aligning maintenance programs with policy goals and Measure HLA requirements.
- 23. Discussion and possible action to agendize for the January 21 General Board meeting to approve a community impact statement for Council File <u>23-1027</u> regarding City Charter Reform, currently in the Ad Hoc Committee on City Governance Reform. Ronee, as our LANCC representative, said he would review what LANCC has done on this and Lorenzo told us he will check with his leadership on whether DONE currently has the capacity to directly provide administrative support to Neighborhood Councils or whether they would want to ask for that authority through the Charter Reform. Another possible item for the community impact statement is who should be responsible for assessing and championing the needs of the Neighborhood Councils for funding and resources sufficient to enable them to accomplish their purpose. According to <u>DONE's About Neighborhood</u> Councils webpage, Neighborhood Councils gather, vet, debate, and come to a consensus on matters that impact City life and policy, and deliver their official stance on these issues in letters called "Community Impact Statements" (CIS), which are shared with City decision-makers, such as the Mayor, City Council, or City Departments such as City Planning. However, there has been no effort to assess or furnish the necessary resources and funding to accomplish this.
- 24. As recommended by the PSHT Committee, discussion and possible action to agendize for the January 21 General Board meeting to approve a community impact statement regarding Council File <u>21-1230-S8</u>, Citywide Code Amendment (CA) / Environmental Clearance (EIR) / Resident Protections Ordinance (Los Angeles City Planning Commission): Introduced October 17, 2024 and referred to Planning and Land Use Management

Committee. Los Angeles City Planning Commission report is relative to the Citywide Code Amendment and Environmental Clearance for the proposed <u>Resident Protections Ordinance</u>.

- 25. As recommended by the PSHT Committee, discussion and possible action to agendize for the January 21 General Board meeting to approve a community impact statement regarding Council File 24-1341, Distinction in Rules / Remodel / Major Renovation / Demolition Project / Los Angeles Municipal Code (Blumenfield Price): Introduced October 25, 2024 and referred to Planning and Land Use Management Committee. Motion is instructing the Department of Building and Safety, with the assistance of the Planning Department, the Bureau of Engineering, in consultation with the City Attorney, to prepare a report with recommendations that explains the differences between a remodel; major renovation, and a demolition project, and which reviews the existing practices and ordinances of other cities in Los Angeles County; and enforcement/compliance with the existing provisions in Municipal code Section 12.23 (Non-Conforming Building and Uses), which already requires that remodels maintain at least 50 percent of an original structure's footprint to maintain any non-conforming rights, improve notification requirements to neighbors, and review all applicable building loopholes in the City's Municipal Code (Zoning and Building Codes). This council file is related to Council File <u>18-0406</u> regarding which the RVNC submitted a community impact statement on August 30, 2024.
