Comments from the public on other matters not appearing on the agenda that are within the assembly's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the assembly is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future meeting. Public comment may be limited to a fixed time per speaker or a limited number of speakers by the presiding officer of the assembly. Those wishing to make comment, but not wanting to speak publicly, may submit written communications to the Board.

AB 361 Updates: Public comment cannot be required to be submitted in advance of the meeting, only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned. Any messaging or virtual background is in the control of the individual board member in their personal capacity and does not reflect any formal position of the Neighborhood Council or the City of Los Angeles.

Motion regarding unpermitted work at Walker's Café and comments to city officials seeking action on this matter and urging that city council act on historic designation of Walker's Café. (Council File: 22-0362)

Parks and Coastline Committee

Resolved, the Coastal San Pedro Neighborhood Council shall transmit the following communication regarding Walker's Cafe to appropriate city officials:

"On July 14th, Prospect Group, the new owners of Walker's Cafe at 700 W. Paseo del Mar in San Pedro, were issued a stop work order after Los Angeles Department of Building and Safety (LADBS) in-

spector Andrew Beeli found them doing unpermitted work on the premises. Despite failing to obtain the required permits from LADBS or the Air Quality Management District (AQMD) for the work being done, and despite having been issued a stop work order, they have continued to do construction onsite. The San Pedro Neighborhood Councils are extremely concerned about the condition of Walker's Cafe, a pending Historic-Cultural Monument and a resource of great significance to the community. We are looking to the Department of Building and Safety to exercise the tremendous leverage they have to protect this resource. We ask the council office to review the situation onsite with the building inspector assigned to the case, Andrew Beeli along with the inspector's supervisor, as well as Councilmember Buscaino's Field Deputy Ryan Ferguson, Lambert Giessinger from the Office of Historic Resources, and the neighborhood prosecutor, Khalil Rasheed.

Following the site visit, we ask that Ryan Ferguson attend our Joint Planning and Land Use Committee meeting as well as Coastal San Pedro Neighborhood Council's Coastline and Parks Committee meeting to report back and tell us what enforcement actions will be taken.

Furthermore, we are extremely concerned about the fact that, following two unanimous 'yes' votes at the Cultural Heritage Commission hearings in January and March, Walker's Cafe remains stuck in limbo, awaiting a PLUM hearing date while illegal and potentially irreversible work on the property is taking place. We urge the City to schedule a PLUM hearing at the next available date in August, 2022. Because this is a serious issue that is unfolding quickly, we would like action taken within thirty (30) days of receipt of this CIS."
