In conformity with the September 16, 2021 enactment of California Assembly Bill 361 (Rivas) and due to concerns over COVID-19, the Coastal San Pedro Neighborhood Council meeting will be conducted entirely with a call-in option or Internet-based service option.

PUBLIC INPUT AT NEIGHBORHOOD COUNCIL MEETINGS — The public is requested to dial *9, when prompted by the presiding officer, to address the assembly on any agenda item before action is taken on an item. Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the agenda that are within the assembly's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the assembly is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future meeting. Public comment may be limited to a fixed time per speaker or a limited number of speakers by the presiding officer of the assembly. Those wishing to make comment, but not wanting to speak publicly, may submit written communications to the Board. *AB 361 Updates:* Public comment cannot be required to be submitted in advance of the meeting, only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned. Any messaging or virtual background is in the control of the individual board member in their personal capacity and does not reflect any formal position of the Neighborhood Council or the City of Los Angeles.

10. Motion recommending that the Board of Harbor Commissioners decline to rename a portion of Harbor Boulevard to “Buscaino Way”.

Whereas a motion to rename the portion of Harbor Boulevard from 8th St. to 22nd St. as “Buscaino Way” was considered by the City Council without committee review; and

Whereas this was done without prior notice to any of the Neighborhood Councils in Council District 15 or to the public in general, and was approved by the City Council is less than four days; and

Whereas the City Charter requires that adequate notice for City decisionmaking be given to Neighborhood Councils:

Section 907. Early Warning System.

The Regulations shall establish procedures for receiving input from neighborhood councils prior to decisions by the City Council, City Council Committees and boards and commissions. The procedures shall include, but need not be limited to, notice to neighborhood councils as soon as practical, and a reasonable opportunity to provide input before decisions are made. Notices to be provided include matters to be considered by the City Council, City Council Committees, and City boards or commissions.

Whereas this motion to rename a street in San Pedro was proposed without any meaningful discussion, or attempt to take into consideration the desires and wishes of community stakeholders; and

Whereas such an action constitutes a self-indulgence by the City Council and Harbor Commission, in contradistinction to their responsibility to respond to stakeholder needs; and

Whereas it is a Councilmember’s civic duty to serve their community and constituency;

Therefore resolved, the Coastal San Pedro Neighborhood Council (CSPNC) strongly opposes the City Council’s request to rename portions of Harbor Boulevard “Buscaino Way” and implores the Board of Harbor Commissioners (Port of Los Angeles) to deny said request. The request should be sent back to the City Council for the appropriate level of review by Committees, Neighborhood Councils, and the public.

Be it further resolved, CSPNC recommends the City Council and Port of Los Angeles both adopt a policy of not naming public streets and buildings for individuals until they have been out of office for more than ten years or are deceased.
