**PUBLIC INPUT AT NEIGHBORHOOD COUNCIL MEETINGS** — The public is requested to dial \*9, when prompted by the presiding officer, to address the assembly on any agenda item before action is take on an item. Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the agenda that are within the assembly's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the assembly is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future meeting. Public comment may be limited to a fixed time per speaker or a limited number of speakers by the presiding officer of the assembly. Those wishing to make comment, but not wanting to speak publicly, may submit written communications to the Board. *AB 361 Updates:* Public comment cannot be required to be submitted in advance of the meeting, only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned. Any messaging or virtual background is in the control of the individual board member in their personal capacity and does not reflect any formal position of the Neighborhood Council or the City of Los Angeles.

# 8. Motion seeking overnight security at Point Fermin, John Milkes Flores, and Angels Gate parks.

Coastline and Parks Committee

Resolved, the Coastal San Pedro Neighborhood Council requests that the City reestablish overnight security in Point Fermin Park, Joan Milke Flores Park, and Angels Gate Park.

#### 9. Motion to oppose application for ADU conversion at 3330 Peck Avenue.

Planning, Land Use and Transportation Committee

Resolved, the Coastal San Pedro Neighborhood Council requests that the application for a conversion from an existing 436-square-foot, two-car garage to an accessory dwelling unit (ADU) at 3330 Peck Avenue, located in the Coastal Zone, be denied as it runs counter to Coastal Zone policies because it reduces existing parking and does not provide additional parking for the new unit.

# 10. Motion requesting native plant landscaping in public spaces.

Environment and Sustainability Committee

Whereas, the Los Angeles region faces a biodiversity crisis wherein over 90% of local butterflies, songbirds, and other pollinators have disappeared in the last century due to the replacement of local flora with non-native plant and tree species; and

Whereas, native landscaping plants and trees can thrive in our urban environment and furnish all the benefits non-native trees can offer in terms of canopy shade to offset the heat island effect, beauty, and shade comfort for humans, while natives provide the only path to sustainability for biodiversity, water and energy savings, and the elimination of soil amendment runoff pollution;

Therefore, the Coastal San Pedro Neighborhood Council appeals to the County and City of Los Angeles, all applicable government agencies, public/private partnerships, and private parties planting in public space to henceforth only plant 100% California native plants and trees within Los Angeles County, the City of Los Angeles, and specifically within the boundaries of the Coastal San Pedro Neighborhood Council except in situations where plants and trees are intended to produce food for human consumption or provide a designated recreational playing field.

#### 11. Motion to request replacement of damaged fence at Alma Park.

Emergency Preparedness and Public Safety Committee

Whereas, there is a collapsed perimeter fence at Alma Park at the end of the alley, extending north from 22nd Street (nearest South Meyler Street), which creates a significant hazard for injury and provides opportunities for vandalism and crime, and

Whereas, the former Park Advisory Board and the current Alma Park Neighbors organization have requested that this fence be replaced since 2015 with no resolution or communication from the Department of Recreation and Parks; Therefore, be it resolved, the Coastal San Pedro Neighborhood Council calls on Councilmember Tim McOsker, the Board of Commissioners of the Department of Recreation and Parks, and the Los Angeles City Department of Recreation and Parks to replace the damaged fence at Alma Park as soon as possible.

## 12. Motion to request removal and cleanup of wrecked boat at White Point.

Moved by Richard Havenick

Whereas, over 21 days have passed since the grounding of a fiberglass sailboat with diesel engine, diesel fuel tank, and lead keel on the rock beach at White Point (vicinity of 1600 West Paseo Del Mar) and emergency personnel from the Coast Guard and County and City of Los Angeles were alerted of the crashed boat; and

Whereas, the wrecked boat presents an environmental hazard to the adjacent marine environment and shore of Coastal San Pedro and County of Los Angeles;

Therefore be it resolved, the Coastal San Pedro Neighborhood Council requests that responsible agencies respond immediately with no further delay to remove any hazardous materials, including diesel fuel, oil, and lead, which appear to be present on the wrecked boat at the foot of White Point in the area of the landslide.
