PUBLIC INPUT AT NEIGHBORHOOD COUNCIL MEETINGS — Comments from the public on agenda items will be heard only when the respective item is being considered. Please note that under the Brown Act, the assembly is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future meeting. Those wishing to make comment, but not wanting to speak publicly, may submit written communications to the Board.

8. Motion to authorize additional expenditure of \$500 to sponsor the International Day of Peace event at Point Fermin Park on September 21.

Resolved, the Coastal San Pedro Neighborhood Council authorizes an additional expenditure of not more than \$500 (making the total sponsorship amount \$2,500) to sponsor the United Nations International Day of Peace event being held at Point Fermin Park in San Pedro on September 21. This event is presented by Jane Goodall's Roots & Shoots USA organization.

9. Motion to support City Council motion 24-0140-S1 requesting analysis of the impact of the Supreme Court's Grant's Pass ruling on rules affecting the homeless and a confidential analysis of the ruling's impact of existing litigation against the City.

Resolved, the Coastal San Pedro Neighborhood Council strongly supports the Los Angeles City Council motion in CF 24-0140-S1 which requests first that the City Attorney analyze the impact of Grants Pass on existing Los Angeles City ordinances relating to sleeping, lying, and storage of property (Los Angeles Municipal Code (LAMC) 41.18, 56.11, and 63.44), and also on existing litigation related to such activities. Further, we support the directive to the Los Angeles City Chief Legislative Analyst and City Administrative Officer to prepare a report on current laws in the rest of the county which may impact the City of Los Angeles. We urge the Housing and Homelessness Committee to quickly pass this measure and send it to the full council with a request that all reports be prepared as soon as possible.

10. Motion to approve a Neighborhood Purpose Grant for the Annual Festival of Philippine Arts & Culture.

Resolved, the Coastal San Pedro Neighborhood Council approves a Neighborhood Purpose Grant in the amount of \$5,000 to Association for the Advancement of Filipino American Arts and Culture for the 30th Annual Festival of Philippine Arts & Culture free event at Point Fermin Park on September 14.

11. Motion requesting a report from Recreation & Parks on current status and future plans for restoring access to the coastline at Wilder's Annex.

Whereas, the access stairway to the shore at Wilder's Annex (the only access point for two miles of coast) was declared unsafe, condemned, and fenced off in June 2018; and

Whereas, we were informed years ago by Recreation and Parks that deferred maintenance funds were available to restore access; and

Whereas, we have neither seen progress nor received progress reports on restoration of access for six years; *Resolved*, the Coastal San Pedro Neighborhood Council requests a report from Recreation and Parks, in person at the September CSPNC Board Meeting, or in writing prior to 16 September 2024, summarizing progress to date and a future timeline for restoration of access to the shore at Wilder's Annex.

15. Motion to amend the budget to allocate rollover funds.

Resolved, the Coastal San Pedro Neighborhood Council shall allocate rollover funds from last year into the following categories:

- \$3,000 to Outreach/Sponsorship
- \$1,600 to Office/Ops/Food
- \$2,000 to NPGs
- \$257.64 to Unallocated


