9. Motion to support Port of Los Angeles grant application for electric vehicle charging stations.

Resolved, the Coastal San Pedro Neighborhood Council shall send a letter of support, requested by the close of business on Tuesday 27 August, for the application by the Port of Los Angeles for grant funding from the U.S. Department of Transportation Federal Highway Administration's Chargine and Fueling Discretionary Grant Program:

Dear Secretary Buttigieg,

On behalf of the Coastal San Pedro Neighborhood Council, I write to express our enthusiastic support for the Port of Los Angeles' (POLA, Port) application to the U.S. Department of Transportation (USDOT), Federal Highway Administration's (FHWA) Charging and Fueling (CFI) Discretionary Grant Community Program for the Port of Los Angeles Electric Vehicle Charging Stations Project (Project).

The Port has established a record of reducing emissions from port-related sources. To date, the Clean Air Action Plan (CAAP) has reduced emissions of diesel particulate matter (DPM), nitrogen oxides (NOx), and sulfur oxides (SOx) by 88%, 62% and 97% respectively since 2005.

This project involves the installation of 85 electrical charging stations across nine locations with 50 charging stations in San Pedro and 35 in Wilmington and represents a tremendous step toward the Port's zero-emission (ZE) goal. The availability of electric vehicle (EV) charging infrastructure, coupled with the subsidies the Port offers for the purchase of ZE trucks, supports and accelerates the transition of the port trucking fleet to zero-emission operations. Furthermore, it concentrates the benefit in areas of persistent poverty reinforcing the Port's commitment to a healthier environment for its neighbors, the communities of San Pedro and Wilmington.

POLA is requesting \$4.997 million in funding from USDOT to be matched with \$1.323 million in Port funding for a total project value of \$6.3 million. Grant funds will be used in the Development (Environmental, Design) and Construction phases, with an estimated start date of March 2025 and a completion date of August 2027.

Successful implementation of this project will serve as a model for other ports in the United States and globally, leading to cleaner air and healthier communities. I respectfully request USDOT to give POLA's application favorable consideration.

Whereas, there was a dramatically reduced ATV presence this year, and

Whereas, even when ATVs did patrol, they typically came through very quickly after closing hours, and they generally didn't engage with people they encountered,

Resolved, the Coastal San Pedro Neighborhood Council requests that the Los Angeles Police Department provide much more regular and thorough all-terrain vehicle (ATV) patrols in our local parks moving forward.

Parks and Coastline Committee

Whereas, after decades of public pressure and a much more engaged Council Office Administration, a heightened willingness to move forward with preparing Sunken City for safe public access, as required in the Certified San Pedro Coastal Land Use Plan (LUP), has developed,

Resolved, the Coastal San Pedro Neighborhood Council asks for implementation of the approved scope of work for which \$1.5M was allocated by the Board of Recreation and Parks Commissioners on April 21, 2022, incorporated herein by reference and attached as a document, starting with making the site safe, as prioritized in the following portion of the scope of work:

Development of any necessary grading, drainage, and site mitigation <u>measures to improve safety conditions</u>.

12. Motion requesting 90 day public review period for the Berths 97–109 [China Shipping] Container Terminal Project Notice of Preparation.

Resolved, the Coastal San Pedro Neighborhood Council requests that the Port of Los Angeles provide a public review period of 90 days (ending 19 November 2024 instead of the legal minimum 30 day period ending on 20 September 2024) for the "Berths 97–109 [China Shipping] Container Terminal Project Notice of Preparation" to allow for community discussion and formulation of a response in a time period that permits neighborhood council deliberations.

2. Composition and Organization of Committees

Committee members who have failed to attend three consecutive committee meetings shall be removed from the committee. This action is automatic and does not require a vote of the governing board.

It shall be the responsibility of committee chairs to monitor the attendance of committee members. If a committee member fails to regularly attend meetings (absence at three consecutive committee meetings or more than half in any 12 months), the chair may recommend to the board removal of that committee member.

In the event the board approves removal of a committee member, that individual shall be notified via email or telephone of their removal.

3. Establishment of Standing Committees

The Governing Board establishes the following standing committees.

Administrative Operations: Responsible for budgetary and fiscal matters, rules and bylaws, and other administrative functions.

Communications: Responsible for all outreach and community relations, including website, publications, and events.

Election Committee: Responsible for conducting the process for election of the Governing Board.

Emergency Preparedness and Public Safety: Responsible for matters related to emergency preparedness and public safety.

Environment and Sustainability: Responsible for matters related to environmental issues and sustainability efforts.

Parks and Coastline and Parks: Responsible for matters related to parks and coastal issues.

Planning, Land Use, and Transportation: Responsible for matters related to planning, zoning, and transportation issues.

Port: Responsible for matters related to the Port of Los Angeles.

5. Authorize RAP staff to make technical corrections as necessary to carry out the intent of this Report.

SUMMARY

Point Fermin Park is located at 807 Paseo Del Mar in the San Pedro community of the City. This 39.13-acre park provides a children's play area, jogging trail, bike path, walking path, picnic tables, pergolas, a historic lighthouse and scenic ocean views. Sunken City is a beachfront portion of Point Fermin Park that was destroyed by a landslide in 1929. Approximately 3,719 residents live within a one-half mile distance of Point Fermin Park. Due to the facilities, features, programs, and services it provides, Point Fermin Park meets the standard for a Regional Park, as defined in the City's Public Recreation Plan.

PROJECT SCOPE

The scope of the proposed Project includes the following:

- Design public access areas, overlooks, and pathways in order to allow for safe public access to portions of the property.
- Development of any necessary grading, drainage, and site mitigation measures to improve safety conditions.

The final scope of work and design for the proposed Project will come back for the Board's consideration in the future.

PROJECT FUNDING

Upon approval of this Report, One Million, Five Hundred Thousand Dollars (\$1,500,000.00) in Park Fees can be committed to the proposed Project.

These Park Fees were collected within ten (10) miles of Point Fermin Park, which is the standard distance for the commitment of Park Fees for regional recreational facilities pursuant to Los Angeles Municipal Code Section 12.33 E.3

TREES AND SHADE

This proposed Project will have an unknown impact on the existing trees and shade at Point Fermin Park.

ENVIRONMENTAL IMPACT

The proposed Project consists of feasibility and planning studies for possible future action, as such studies include consideration of environmental factors.

As such, staff recommends that the Board of Recreation and Parks Commissioners' (Board) determines that the Project is statutorily exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Article II, Class 2(d) of City CEQA Guidelines and Article 18, Section 15262 of California CEQA Guidelines. RAP Staff will file a NOE with the Los Angeles County Clerk upon the Board's approval.

FISCAL IMPACT

The approval of this commitment of Park Fees for this Project will have no fiscal impact on RAP's General Fund. The estimated costs for this Project design, development, and construction of the proposed park improvements are anticipated to be funded by Park Fees or funding sources other than RAP's General fund. The impacts to future maintenance operations are unknown at this time.
