8. Request for enforcement of law at the Point Fermin Marine Life Refuge.

Coastline and Parks Committee

Whereas, marine life is being regularly illegally taken from the Federally and State protected Point Fermin Marine Life Refuge which is also being heavily polluted and vandalized on a continual basis,

Resolved, the Coastal San Pedro Neighborhood Council implores the Department of Fish and Wildlife to enforce the laws protecting this area, and

Further Resolved, we request that representatives from the department come meet with us at the Marine Refuge to view the damage first hand and help us develop an effective monitoring and enforcement policy.

Whereas, Extreme Heat, Sea Level Rise and Coastal Flooding, Extreme Precipitation and Flooding, Wildfires, and Drought affect all residents of Los Angeles and mustn't be considered in isolation as applying to only a few groups, and

Whereas, residents at all income levels of the Coastal Zone in particular, are vulnerable to Sea Level Rise and Coastal Flooding, as well as the other areas of study,

Resolved, the Coastal San Pedro Neighborhood Council requests that the following issues be included in the Climate Vulnerability Assessment (CVA) that the City is currently developing:

- 1. Wave action on bluffs and cliff erosion and failure can cause rock slides and property damage which can also impact and cause harm to people.
- 2. Mud slides related to heavy rains.
- 3. Drought affects water supply to all regions. We may only have a couple of years of storage which can also be impacted by earthquakes.
- 4. Sea Level Rise can affect 35% of Port of Los Angeles Buildings exposed under 1 meter Sea Level Rise scenario.
- 5. Flooding of underground storm water drains and sewer systems creating potential public health and sanitation risks as well as threatening water supplies.
- 6. King Tides add extra stress to the Port and surrounding community and exacerbate Sea Level Rise impacts.
- 7. Encampments and fireworks cause wildfires in our area.
- 8. Infrastructure that supports our entire area can be damaged by Sea Level Rise.

10. Motion supporting Council File 24-1337 (Large Asphalt Repair / Repair Alleys / Damage Caused by Sanitation Trucks).

Resolved, the Coastal San Pedro Neighborhood Council strongly supports Council File 24-1337, which seeks inspection and cost estimates for repair of alleys in Council District 15.

11. Motion to hold a selection for the next Coastal San Pedro Neighborhood Council election.

Resolved, the Coastal San Pedro Neighborhood Council (CSPNC) chooses to carry out its own election/ selection process for choosing board members for the 2025–7 term. CSPNC will choose its board using a secret ballot process. Our right to determine the method by which we choose our board members is guaranteed by the language in section 9 of the Los Angeles City Charter.

Further resolved, the Coastal San Pedro Neighborhood Council requests that the deadline for applying to conduct a selection process be extended until December 2, 2024.

12. Motion to amend Coastal San Pedro Neighborhood Council Bylaws (second reading).

Administrative Operations Committe

Resolved, Coastal San Pedro Neighborhood Council Bylaws Articles V and XII shall be amended as follows (deleted text in strikethrough, added text in underlined boldface):

Section 7. Absences. If a Board Member is absent from four (4) consecutive, regularly-scheduled Board meetings, his or her seat shall be vacant the Board may remove the Board member by ²/₃ vote of Board Members present at a regularly scheduled Board Meeting.

Article XII — Parliamentary Authority

The most recent edition of Robert's Rules of Order, <u>Newly</u> Revised shall be the parliamentary authority at meetings of the Council.



MOTION

For residents throughout the City of Los Angeles, the alleys and alleyways serve as the main access points to coming and going from their homes. For residential apartments or homes, garages are often located at the back of houses or apartment buildings which are accessed through alleys.

In Council District 15, multiple alleys have been significantly impacted by Los Angeles Bureau of Sanitation trucks that have caused damage due to bulky item pickup, 311 requests, or waste management-related activity. Repairs can be made to alleys with "Large Asphalt Repair" which requires specific equipment and available personnel resources.

I THEREFORE MOVE that the City Council request the Los Angeles Bureau Street Services, with the assistance of the City Administrative Officer, conduct and inspect alleys requested for repair throughout Council District 15 and provide a cost estimate for repairs needed, inclusive of the cost for equipment and personnel needs.

I FURTHER MOVE that the City Council request the Los Angeles Bureau Street Services, with the assistance of the City Administrative Officer, conduct and inspect alleys requested for repair throughout the City of Los Angeles and provide a cost estimate for repairs needed, inclusive of the cost for equipment and personnel needs. This should include a priority list for alleys in each Council District. Additionally, the report should include innovative and sustainable pathways to fund this work.
