Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, issues raised by the public may become the subject of a future Board meeting. Public comment is limited to one minute per speaker, unless adjusted by the presiding officer of the Board.

Making Public Comments During This Virtual Meeting: When prompted by the Presiding Officer, press "Raise Hand" (if on Zoom) or *9 (if on a telephone) to indicate a desire to address the Council. If you are on Zoom, you will see a timer graphic indicating your time remaining to speak. If you are on a telephone, you will be told when 10 seconds remain in your allotted time.

SB 411 Updates: If a Neighborhood Council has a quorum of board members in a physical location, board members who wish to join the meeting via teleconferencing must adhere to AB 2449 rules and regulations. If a Neighborhood Council does not have a quorum of board members in a physical location, they must adhere to SB 411 rules and regulations. In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to § 54960.1. <u>CF 19-1020</u>. Commission on Lived Experience w Homelessness. **Pos: FOR**. *Draft Motion:* The Sherman Oaks Neighborhood Council (SONC) supports Council File 19-1020 which seeks to establish a Commission on Lived Experience with Homelessness, composed entirely of people who are currently, or have been in the recent past, homeless in Los Angeles.

Considering the recent passage and multiple extensions of an Emergency Ordinance regarding the unhoused resident population, and the quickly approaching Council File deadline, this matter should be considered extremely urgent. We request that the Housing and Homelessness committee Chair, Councilmember Raman of District 4 bring the item to City Council forthwith; and report back to SONC within 30 days.

ii. Neighborhood Council Youth Representatives and Term Limits.

<u>CF 24-0867</u>. Neighborhood Council Bylaws / Youth Participation / Diversity Increase / Leadership Growth. **Position:** <u>AGAINST</u>.

Draft Motion: The Sherman Oaks Neighborhood Council (SONC) opposes Council File 24-0867 which requests two separate actions from the Board of Neighborhood Commissioners: 1) bylaw amendment guaranteeing a youth seat on each NC, and 2) bylaw amendment instituting term limits for all NCs.

While SONC supports the goals of request #1 pertaining to youth membership, we oppose this motion due to #2's desire to institute term limits for a vulnerable NC system which already has difficulty achieving membership goals and often relies on seasoned council members for expertise and institutional knowledge.

*SB411 / SECTION 54953.8 DISCLAIMER FOR VIRTUAL MEETING

- (C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.
- (D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.
- (E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph (D), to provide public comment until that timed public comment period has elapsed.
- (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.
- (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.
