The Silver Lake Neighborhood Council acknowledges all of the original stewards and inhabitants of the Los Angeles Basin, or Tovaangar, and their descendants. - d. **NPG request- Silver Lake Improvement Association - requesting up to \$5,000** for cleaning Sunset Triangle Plaza: \$3,500 Power wash monthly @ \$750 (2 months), weekly cleaning @ \$500 (4 weeks). Vendome Street Median: \$1,500 Clean twice a year, \$750 per cleaning.
- e. **NPG request- Silver Lake Reservoir Conservancy - Native Plant Giveaway - requesting up to \$320** to purchase 4" and 1 gallon native plants to distribute for free to local residents and provide supporting printed materials. The objective is to educate the public about the importance of native plants in their gardens to support local wildlife and enhance local biodiversity
- f. **NPG request- Bici Libre** - recommended by SELAH, they are **requesting up to \$5,000** to purchase new tools as well as new basic bike parts, locks, helmets and lights in order to help the lowest income cyclists repair their bikes - Bici Libre is located outside of Silver Lake, though they are part of SELAH's Saturday drop-in program at Silver Lake Community Church.
