2. Government Affairs Motions

- a) Motion A: The Board of the Studio City Neighborhood Council (SCNC) *supports* Council File 24-0294 for the Bureau of Engineering, with the assistance of the Bureau of Street Services, Department of Recreation and Parks, Department of Transportation, and the Bureau of Street Lighting, to report with recommendations to determine which agencies will be responsible for maintenance of current and future pedestrian bridge and tunnel projects, as well as, the current maintenance responsibilities for existing pedestrian bridges and tunnels, including ongoing funding needs for maintenance, and to report with recommendations to ensure consistent maintenance policies across all existing pedestrian bridges and tunnels.

This motion is also to be submitted as a Community Impact Statement (CIS) to [Council File 24-0294](#)

- b) Motion B: The Board of the Studio City Neighborhood Council (SCNC) *supports* Council File 23-0700 the General Services Department and Security Services to report back in 30 days from August 31, 2023 on the infrastructure and safety upgrades necessary to resume its pre-pandemic regular schedule by January 1, 2024 for regularly scheduled monthly or bi-monthly City Council Meetings in Van Nuys to serve as a catalyst for Valley issues where more than 40% of the citizens of the City of Los Angeles reside. This report back is now 8 months overdue.

### 3. Sustainability Committee Motions

- a) Motion A: The Studio City Neighborhood Council supports [Council File 24-0602](#) on the condition it urges the Council to amend the motion using the recommendations by the [Climate Reality Project](#). Not only does artificial turf have PFAS and pollute ground water, it also: emits methane, cannot be recycled, creates heat islands, destroys the soil beneath the turf, and suffocates surrounding trees just to name a few of the impacts artificial turf has on the community.  
This motion is to be submitted as a CIS to Council File 24-0602
- b) Motion B: The Studio City Neighborhood Council recognizes the oak/walnut woodland on the Sunswept hillside, abutting Ventura Boulevard on the south side, between Sunswept and Fairway, is an important, rare, and endangered habitat. We ask CD4 to help us protect the area from development and preserve it for long term conservation. This is a request for action to CD4.

- c) Motion C: The Studio City Neighborhood Council believes the mature Oaks and Conifer trees that occur in the southern median between Van Noord and Fulton Avenue are amongst the largest and oldest trees in Studio City. The grove has significant community and environmental value. We request CD 4 to help us certify this planting as a community asset and help ensure its preservation and maintenance in a manner that enhances its community utility. This is a request for action to CD4.

### 4. Transportation Motions

- a) Motion A: The Board of the Studio City Neighborhood Council (SCNC) *supports* [Council File 21-0956-S2](#) to clarify enforcement of vehicles used as dwellings which are parked or stopped in a peak hour travel lane or at locations that do not allow stopping at any time and subject to immediate towing. These vehicles are deemed a traffic safety/hazard and have been inconsistently enforced.
- b) Motion B: The Board of the Studio City Neighborhood Council (SCNC) requests Councilmember Nithya Raman and the Los Angeles Department of Transportation (LADOT) to install Speed Humps on Woodbridge Street at appropriate intervals between Whitsett Avenue and Coldwater Canyon Avenue.

### 5. PUBLIC SAFETY COMMITTEE PASSED MOTIONS – April and May

- a) Motion A: The Board of the Studio City Neighborhood Council (SCNC) supports Council File 23-0002-S123: SB 1509 (Stern) / Negligent Operator Treatment (NOT) in

California Act / 26 mph or higher / Two-Point Violation / Drivers License Suspension / Revocation. California ranked second in the country for the most speed-related traffic fatalities in both 2020 and 2021, and in 2023 it marked the first time there were more traffic fatalities in the state than homicides. In 2021, there were 4,285 traffic fatalities. Speed-related traffic collisions are a growing safety danger to all Californians. All of us have seen reckless drivers speed through our neighborhoods with abandon. A bill in the State Senate, SB 1509, would help combat speeding vehicles by increasing points from one to two for a conviction of driving 26 mph or higher over the posted speed limit; thereby placing the driver's license at risk of suspension or revocation. The SCNC urges the City Council to support this bill to help mitigate reckless driving and speed-related collisions. This would make our community safer.

- b) Motion B: The Board of the Studio City Neighborhood Council (SCNC) supports Council File 24-0562: Bus Driver / Transit Rider / Safety / Protection / Assessment / Los Angeles Department of Transportation / Los Angeles Police Department / MV Transportation / Teamsters Local 572. Bus drivers of the Los Angeles County Metropolitan Transportation Authority (Metro) staged a "sick out" in April 2024 to protest assaults and other safety concerns against bus drivers. Unfortunately, such assaults are all too common on the Metro. In April, a DASH driver was assaulted by a homeless woman. A rider of the Red Line was fatally stabbed recently. This is unacceptable. While city officials want the public to use public transportation like buses and the subway more, the public will not use the city's transit system as long as safety concerns remain. Our public servants and residents should not be subjected to violence when using Metro transportation. More needs to be done, such as hiring more peace officers to patrol the Metro system. This motion instructs the Los Angeles Department of Transportation (LADOT) to report on an assessment of bus drivers' and transit riders' safety concerns and to provide recommendations to protect both workers and the public from violence.

**Studio City Neighborhood Council Committee Meeting Agendas are posted for public review on the SCNC website at [studiocitync.org](http://studiocitync.org) and at the Radford Studio Center gate on Colfax Avenue, as well as, at the gate on Radford Avenue.**

All Stakeholders are required to park in (or walk into) the studios' Sater parking structure at 4200 Radford Avenue. There are a limited number of accessible parking spaces in front of the meeting room and while there is no direct path of travel to the meeting room via a sidewalk, the studio and SCNC want to assure that Stakeholders with disabilities are able to access the meeting without difficulty. Stakeholders with disabilities who have a valid DMV placard, use a wheelchair, walker or cane, and/or those who have difficulties walking distances should contact Radford Studio Center Security Office at 818-655-5085 to request shuttle assistance at least 24 hours prior to the meeting in order for the studio to arrange services for the meeting.

**Radford Studio Center**  
**Audience Shows & Events Policies**

**To attend an audience, show, event, or public meeting at Radford Studio Center, the following items are required:**

- Valid Government issued Driver's license if you are driving a vehicle onto the lot.
- Valid Government issued Identification card if you are walking onto the lot. A Military ID and Passport ID will suffice.
- An adult must accompany minors (17 years old and younger). Student ID cards are preferred for those who have them.

**The following items are prohibited on your person while attending an audience show, event, or public meeting on Radford Studio Center property:**

- Knives
- Mace/pepper Spray
- Sharp Objects
- Firearms
- Alcoholic beverages
- Drugs (including marijuana for medicinal purposes)

All guests are subject to security screening and search. Guests will be required to pass through a metal detector or screened using a hand-held metal detector.

- Once the audience member has emptied their pockets and turned over any prohibited items, the audience member will be instructed to proceed through the metal detector or screened using a hand-held metal detector.
- Should the audience member activate the metal detector, the person will be asked to step to the side and will be scanned (entire body length front and backside) by the Security Officer with the hand-held metal detector.
- The audience member will not be allowed into the Studio until the Security Officer is satisfied that the individual has nothing on his/her person that constitutes a danger to others.
- Should the guest refuse to be screened, they are subject to being denied access to Radford Studio Center property.
- **NO FIREARMS OF ANY KIND ARE ALLOWED INSIDE THE STUDIO.** Security Officers who detect that a guest is in possession of a firearm should notify the Security Supervisor and P.O. IMMEDIATELY.
- Off-duty Law Enforcement in possession of a firearm will be instructed to either return the weapon to their vehicle or turn it over to Security where it will be kept, UNLOADED, in a SAFE, located in the security manager's office.
- Any props or toys that resemble weapons in any way are to be denied or confiscated. This includes props / accompanying costumes.

Each guest/audience member will be required to submit a form of identification which will be tagged with an item that is confiscated and held with security. Guests and audience members will be instructed to pick up their confiscated items at the first (1<sup>st</sup>) level of the Sater parking structure near the elevators at the completion of the event. No personal pets are allowed at any time on the Studio lot.

**If, at any time, an audience member or guest, wanders away from their event or meeting space, into an unauthorized area, that person is subject to immediate dismissal from the lot.**
