#### Treasurer's Motions – Kim Clements

**Motion A:** The Board of the Studio City Neighborhood Council *approves* reimbursement to SCNC board member Jerry Lewis in the amount of \$320.33 for the purchase of pizza from Prince Street Pizza for two Regular Board Meetings: 1. #### Government Affairs Committee – Barry Johnson

**Motion A:** The Board of the Studio City Neighborhood Council (SCNC) *supports* Council File 25-0046 to instruct the City Administrative Officer, with the assistance of the Chief Legislative Analyst, the City Attorney, and the Los Angeles Fire Department to report back within 60 days with recommendations on a proposed ballot measure for the June 2026 Election which would seek to implement a Bond measure that would provide funding for the needed maintenance of

current Fire Stations and capital for construction of much needed new fire stations, that would bring the Fire Department up to the standards needed for the next 50 years.

This motion is also to be submitted as a Community Impact Statement (CIS) to Council File <u>25-0046</u>.

**Motion B:** The Board of the Studio City Neighborhood Council (SCNC) *supports* Council File 25-0002-S4 for a City of Los Angeles Resolution to the State Legislature to include in its 2025-2026 State Legislative Program SUPPORT and/or SPONSORSHIP for any legislation that prevents the monopolistic concentration of homeownership in fire-damaged areas and encourages recovery efforts that prioritize the needs of families over the interests of large investors.

This motion is also to be submitted as a Community Impact Statement (CIS) to <u>Council File</u> <u>25-0002-S4</u>.

**Motion C:** The Board of the Studio City Neighborhood Council (SCNC) *supports* Council File 25-0006-S28 to instruct the Los Angeles Department of Water and Power, with the assistance of any needed department or government agency, to report back on the feasibility and implementation of a tiered system for undergrounding powerlines. This report should also include the following information:

• Criteria for prioritizing areas for undergrounding, such as risk factors like Very High Fire Hazard Severity Zones;

• A detailed cost analysis, including projected costs for different tiers, potential funding options, and the impact on utility rates and customers; and

• Strategies for community input and stakeholder engagement processes.

This motion is also to be submitted as a Community Impact Statement (CIS) to <u>Council File</u> <u>25-0006-S28.</u>

**Motion D:** The Board of the Studio City Neighborhood Council (SCNC) *supports* Council File 14-0366-S36 to instruct the City Attorney to assess and report on recommendations to improve the enforcement mechanisms of unauthorized cannabis shops with the goal of preventing them from resuming operations after having been closed down.

This motion is also to be submitted as a Community Impact Statement (CIS) to <u>Council File</u> <u>14-0366-S36</u>.

#### Transportation Committee – Barry Johnson

**Motion A:** The Board of the Studio City Neighborhood Council (SCNC) *requests* Councilmember Nithya Raman and the Los Angeles Department of Transportation to name part of Ventura Boulevard in Studio City, "Sushi Row". There is precedent for a sign of this type already with "Gallery Row" signs placed in a neighborhood in downtown Los Angeles, designated by the City Council in 2003 to promote the concentration of art galleries along Main and Spring Streets. These signs are the standard blue City sign with the City Seal. Link to example **Motion B:** The Board of the Studio City Neighborhood Council (SCNC) *requests* Councilmember Nithya Raman and Councilmember Adrin Nazarian to make a joint Motion to have Uber Eats, Doordash and other delivery services have City-issued I.D. Badges for their drivers and dashboard placards for their vehicles displayed at all times, because without these forms of I.D. it makes it impossible for citizens to make complaints.

**Motion C:** The Board of the Studio City Neighborhood Council (SCNC) *supports* Council File 25-0002-S2 for a City of Los Angeles Resolution to the State Legislature to include in its 2025-2026 State Legislative Program SUPPORT and/or SPONSORSHIP for any legislation that results in amendments to the State Density Bonus Law to ensure that evacuation routes within High Fire Severity Zones and those areas immediately outside High Fire Severity Zones are not overwhelmed by dense development that impedes the safe passage of people fleeing life threatening circumstances. This motion is also to be submitted as a Community Impact Statement (CIS) to <u>Council File 25-0002-S2</u>.

**Motion D:** The Board of the Studio City Neighborhood Council (SCNC) *supports* <u>Council File</u> <u>12-1657-S14</u>

**Motion E:** The Board of the Studio City Neighborhood Council (SCNC) *requests* the Los Angeles Department of Transportation (LADOT) to *study* changing the sequence and length of the traffic signal at the 101 Southbound and Northbound, On and Off Ramps, at Laurel Canyon Boulevard, to relieve the back up of traffic turning into and out of the 101 overpass by Campbell Hall School, especially during school drop off/pick up times when the turning lanes become blocked with parents and students going in/out from the school.

**Motion F:** The Board of the Studio City Neighborhood Council (SCNC) *requests* the Los Angeles Department of Transportation (LADOT) to *study* extending the length of time for the left turn arrows at Moorpark Street and Laurel Canyon Boulevard, therefore relieving the long back up of left turning traffic (Northbound and Southbound, Eastbound and Westbound) that due to a short left-turn lane and long lines of traffic make for long wait times and blocks traffic going straight ahead further behind the turn lane.

#### Public Safety Committee – Jeff Hartwick

**Motion A.** The Board of the Studio City Neighborhood Council (SCNC) *requests* that Councilmember Raman support the very important Community Emergency Response Team (CERT) program by providing funding from AB1290 Fund No. 53P account #281204 (Council District 4 Redevelopment Projects – Services) in the amount of \$50,000. The Los Angeles Fire Department (LAFD) has suffered from staffing and resource shortages that have had a deleterious impact on the recent wildfire response. LAFD's CERT program trains community members on how to respond to all forms of hazards, including medical emergencies and natural disasters. Many CERT members provided support to the LAFD during the fires. CD4 is currently at risk of losing access to the CERT program due to lack of funding. The requested transfer of funding would provide CD4 residents and stakeholders with the necessary resources to ensure access to the lifesaving CERT courses and programs. **Motion B** : The Board of the Studio City Neighborhood Council (SCNC) *supports* Council File 25-0111: Title, Super Scoopers / Large Amphibious Aircraft / Funding Plan / Locally Housed. A "Super Scooper" is a large amphibious aircraft that scoops water from bodies of water to drop on wildfires. These aircraft have been critical tools in the fight against the Palisades and other fires. Unfortunately, Super Scoopers are leased from Canada. Given the intensity of recent fires,locally based Super Scoopers would be crucial to timely respond to rapidly spreading fires in our city. This motion requests a report on a funding plan to purchase one or more of these aircraft, a stationing plan, and the efficacy of collaborating with other governments in sharing them. This motion is also to be submitted as a Community Impact Statement (CIS) to <u>Council File 25-0111</u>.

**Motion C**. The Board of the Studio City Neighborhood Council (SCNC) *requests* that Councilmembers Raman and Nazarian make a motion to reestablish the Neighborhood Prosecutor's Program. This program began in 2012. Neighborhood Prosecutors were assigned to individual police stations and dealt with community problems like party houses, squatters in abandoned homes, illegal dumping, drug sales, and graffiti. City Attorney Hydee Feldstein Soto unfortunately reassigned the Neighborhood Prosecutors, effectively terminating the program. The program was replaced by a "Community Law Corps," which is more of a social justice program than a law-and-order program. Many police officers and stakeholders believe this move was short-sighted, as the program provided a direct link with the community to help with chronic local crime problems. The Neighborhood Prosecutors should be returned to our local police stations to more effectively and quickly respond to big community problems.

**Motion A.** The Board of the Studio City Neighborhood Council (SCNC) *opposes* Council File 25-0112: Title, Esperanza Immigrant Rights Project / Removal Proceedings / Stop-Gap Funding / City-Owned Property / Non-Profit Legal Services Providers / RepresentLA Program. This motion seeks to identify \$540,000 in city funds and the use of city property near federal immigration courts to provide legal services to non-citizens subject to federal removal proceedings. Reasons why immigrants are subject to removal include: criminal convictions, participating in criminal acts, being a drug dealer, violating terms of a visa, being arrested, and being a threat to public safety. At a time when the city faces budget problems, it makes little sense for the city to spend precious taxpayer funds for the legal defense of migrants in violation of the law. The over half million dollars should be used instead to fund law enforcement programs. This motion is also to be submitted as a Community Impact Statement (CIS) to <u>Council File 25-0112</u>.

Every person wishing to address the Committee must dial 669-444-9171, and enter 898 684 8286 and then press # to join the meeting. When prompted by the presiding officer, to provide public input at the Neighborhood Council meeting the public will be requested to dial \*9 or use the Raise Hand option, to address the Committee on any agenda item before the Committee takes an action on an item. Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the agenda that are within the Committee's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Committee is prevented from acting on a matter that you bring to its attention during the General Public Comment period: however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to 2 minutes per speaker, unless adjusted by the presiding officer of the Board. SB 411 Updates: In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1. (C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time. (D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate. (E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph (D), to provide public comment until that timed public comment period has elapsed. (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment. (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

#### Audience Shows & Events Policies

### To attend an audience, show, event, or public meeting at Radford Studio Center, the following items are required:

- Valid Government issued Driver's license if you are driving a vehicle onto the lot.
- Valid Government issued Identification card if you are walking onto the lot. A Military ID and Passport ID will suffice.
- An adult must accompany minors (17 years old and younger). Student ID cards are preferred for those who have them.

### The following items are prohibited on your person while attending an audience show, event, or public meeting on Radford Studio Center property:

- Knives
- Mace/pepper Spray
- Sharp Objects
- Firearms
- Alcoholic beverages
- Drugs (including marijuana for medicinal purposes)

All guests are subject to security screening and search. Guests will be required to pass through a metal detector or screened using a hand-held metal detector.

- Once the audience member has emptied their pockets and turned over any prohibited items, the audience member will be instructed to proceed through the metal detector or screened using a hand-held metal detector.
- Should the audience member activate the metal detector, the person will be asked to step to the side and will be scanned (entire body length front and backside) by the Security Officer with the hand-held metal detector.
- The audience member will not be allowed into the Studio until the Security Officer is satisfied that the individual has nothing on his/her person that constitutes a danger to others.
- Should the guest refuse to be screened, they are subject to being denied access to Radford Studio Center property.
- NO FIREARMS OF ANY KIND ARE ALLOWED INSIDE THE STUDIO. Security Officers who detect that a guest is in possession of a firearm should notify the Security Supervisor and P.O. IMMEDIATELY.
- Off-duty Law Enforcement in possession of a firearm will be instructed to either return the weapon to their vehicle or turn it over to Security where it will be kept, UNLOADED, in a SAFE, located in the security manager's office.
- Any props or toys that resemble weapons in any way are to be denied or confiscated. This includes props / accompanying costumes.

Each guest/audience member will be required to submit a form of identification which will be tagged with an item that is confiscated and held with security. Guests and audience members will be instructed to pick up their confiscated items at the first (1<sup>st</sup>) level of the Sater parking structure near the elevators at the completion of the event. No personal pets are allowed at any time on the Studio lot.

If, at any time, an audience member or guest, wanders away from their event or meeting space, into an unauthorized area, that person is subject to immediate dismissal from the lot.
