General Public Comment: Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to two minutes per speaker, unless adjusted by the presiding officer of the Board.

Public comment by any one individual, exclusive of General Public Comment, shall be limited to a total of six (6) minutes per meeting and no more than two (2) minutes per agenda item. Public comment on any agenda item shall be allocated in one (1) minute increments. In no event shall time be allocated for less than one (1) full minute. The above time limitations are subject to adjustment by the presiding officer in conformity with the Brown Act.

2. Public Comments – Comments from the public on non-agenda items within the Board's subject matter jurisdiction. Public comments are limited to two minutes per speaker.

Discussion and motion: Resolved: The TNC Board agrees to allow El Caballero Country Club and/or the LPGA to use the light standards on Ventura Blvd. from Lindley to Nestle and on Ventura Blvd. from Avenida Hacienda to Reseda Blvd which currently display TNC banners, from March 1, 2025 to April 21, 2025 for the purpose of displaying banners announcing the 2025 LPGA JM Eagle LA Championship. Further, the use of the light standards shall be conditioned upon El Caballero Country Club and/or the LPGA executing a Letter of Agreement to be issued by the Los Angeles City Clerk's Office setting forth, among other things, who will pay for the removal and reinstallation of the TNC banners; the replacement of any damaged TNC banners; and the procurement of any necessary permits.
