Greater Toluca Lake Neighborhood Council (GTLNC) **Community Impact Statement**



Tuesday, October 21st, 2025

The Greater Toluca Lake Neighborhood Council (GTLNC) opposes Council File 25-1181 (Lee, Padilla) 2028 Olympic and Paralympic Games / Expand Private Use Helipads / Existing Inventory.

This proposal to approve public helipads citywide for private use seeks to privatize, or partially privatize, a public asset with no end date, shifting ownership or control of services and properties from the public sector to private companies.

The Olympics Committee is one of the wealthiest organizations in the world, with combined assets of \$11 billion. Revenues from the last Olympics in Tokyo in 2020 were \$7 billion*. The Olympics can fund and organize alternative helipad facilities for the short time that the Olympics are held in the City of Los Angeles, without burdening the public infrastructure.

Los Angeles County helipads are paid and maintained by Los Angeles County tax payers and should only be used for emergency services, medical, fire and law enforcement. Additional concerns include the question of liability in the event of an accident on a publicly owned helipad and the need for properly issued permits.

Greater Toluca Lake Neighborhood Council (GTLNC) Community Impact Statement

The Greater Toluca Lake Neighborhood Council (GTLNC) supports Council File 25-0002-S88 (Blumenthal et al. – Raman) 2025-26 Federal Legislative Program / <u>H.R. 5205 - Airport Noise Reduction Act</u>, with amendments.

GTLNC welcomes legislation aimed at reducing aviation related noise and H.R. 5205 is a good start. However, it relies on operators of General Aviation (GA) Airports in Los Angeles County to contact the Federal Aviation Administration when discussing changes to aircraft flight patterns. This is a time-consuming process for residents of the communities surrounding such airports who seek faster relief from aircraft-related noise and pollution.

Therefore, H.R. 5205 should be modified to allow operators to quickly discuss specifically faster rates of climb (ROCs), to a minimum altitude of 3,000 feet, and a more equitable distribution of takeoffs over a larger geographical area as well as a reduction in engine revving above 1,000 feet.

Zone 0 Fact Sheet

Background on Defensible Space: https://bit.ly/Def-Space (link is case-sensitive)

- California passed AB3074 and SB504 requiring the Board of Forestry and Fire Protection ("Board") to establish a defensible zone of the first 5 feet around a structure – aka "zone zero."
- The Governor issued an executive order requiring the Board to complete this rulemaking by 12/31/25.

Summary:

- The goal of zone zero is to reduce fire risk to homes/structures by reducing direct ignition through flame contact and embers.
- Items that may require removal within zone zero include vegetation (all types), gates, fences, sheds, turf, and potted plants.
- Existing structures will have 3 years to comply. It is expected that fire departments may conduct inspections in high fire risk areas.
- There is not currently a proposed appeal process (e.g., to ask for an exemption for a specific plant/item) or a proposed financial aid mechanism.
