A. Administrative Funding Request, 2024 Homeless Count, Refreshments: Request \$500 UNNC Homelessness Liaison Committee requests up to \$500 for food for volunteers for the annual 2024 Homeless Count in January. Executive Committee approved. – DISCUSSION AND ACTION

# B. Administrative Funding Request, and Event Approval, CERT Neighborhood Team Program: Request \$800

UNNC Public Safety-Emergency Preparedness Committee requests up to \$800 for handouts and light refreshments for the LAFD South Bureau Cert Team-UNNC "Cert Neighborhood Team Program" workshops with six sessions beginning January 9. ## C. Ignited Light, NPG: Request \$2,000

Ignited Light sponsors an annual Martin Luther King Day of Service providing free medical, dental, employment, and legal services, and food distribution, this year for two days (January 12 and 13, 2024). Ignited Light requests an NPG of \$2,000 to assist with the purchase of 50 boxes of food from World Harvest Food Bank. Executive Committee recommends \$1,250, and that Ignited Light work with World Harvest or other food bank resource to reduce the price of food boxes. – DISCUSSION AND ACTION

St. Andrews Pl., Case No. AA-2023-374-PMLA-HCA and ENV-2023-375-CE: Proposed demolition of c. 1909 single family residence and subdivision of an R2 parcel into two parcels in the Angelus Vista Character Residential CPIO overlay zone that would allow for the construction of two 3-story duplexes on the two separate parcels, each meeting the minimum zoning 5,000 sf lot size (current single parcel is 13,150 sf). At previous meetings, community members stated that the current SFR was being utilized as an 18-bedroom, 9-bathroom boarding house rental (per MLS description) for up to 36 individuals. Hearing is scheduled in December.

UNNC had previously drafted a letter regarding one such project proposed within a Character Residential District CPIO. Subsequently the City Planning Commission adopted and recommended to City Council proposed regulations for 100% affordable housing projects that do include some considerations for historic districts, CPIOs and other specific plans. ## **Telecommunication Relay Services**

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico and the U.S. territories for local and/or long distance calls. TRS providers – generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user. What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TIY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service.

Don't hang up! Some people hang up on TRS calls because they think the Communications Assistant (CA) is a telemarketer. If you hear, "Hello. This is the relay service ... " when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.

CRS CAs do not participate in the conversation and acquire no benefit from information relayed.
