i. CIS RE Council File 24-0147, Proposed Creation of a New Density Bonus Incentive for Large Family Units: This Council Motion would promote the construction of large family units in new apartment buildings (with 3, 4 or 5 bedrooms and extra bathrooms). Incentives would include square footage exemptions and an additional story. These units would be subject to a 99year covenant that the units would be available to households earning 120% of the Area Median Income. UNNC Planning & Zoning recommends the Governing Board adopt the following CIS:

Draft CIS: UNNC has an important perspective that needs to be represented in this discussion. Therefore the committee recommends that the document should be refined in order to better address the community it's intended to support. Family-serving housing should have sufficient green space and public/common space. Given that the intention is to incentivize the construction of apartment units to accommodate families, any building applying for these incentives shall not allow additional waivers that would reduce the required amount of open space, landscaping or trees. Moreover, the principle behind an incentive is that there has to be a need, and that, and as far as this goes, there should be a need for an underserved population. However, the motion itself does not present data demonstrating that such a need exists. Therefore the City Council should also require that such data be calculated. The incentives also should NOT apply to Co-Housing proposals, and should only apply to family-serving housing. Last, UNNC is concerned about the income levels referenced in the motion. Given the income levels of our local families in need, UNNC believes that 120% of Area Median Income is too high for an incentive program. And we are also concerned that it would be difficult to have measurable analysis of household income if non-related roommate housing is included in the program. – **DISCUSSION AND ACTION**

ii. Case No. ADM-2024-174-DB-VHCA-ED1, 2075 West Jefferson (corner Arlington):

Construction of a new 100% Affordable 51,655 sq. ft., 6-story, 71'6"tall, 100-unit apartment building. ED-1 administrative case (79 low income, 20 moderate income, one manager unit) but located within Jefferson Park HPOZ. Actual zoning is C2-1VL-O-HPOZ-CPIO (height district = "very low"). UNNC Planning & Zoning Committee recommends that UNNC Governing Board support letter of opposition authored by the community group, Jefferson Park United. (Letter is in the online agenda packet). – **DISCUSSION AND ACTION**

iii. Council File No. 23-0623-S1, CPC-2023-5273-CA (Mayor's Emergency Directive ED-1), Streamlining Affordable Housing: Proposed Community Impact Statement regarding proposed implementation ordinance amending Los Angeles Municipal Code Chapters 1 and 1A, to establish procedures and performance standards for administrative approval of 100% affordable housing projects.

Draft CIS: UNNC has a strong record of supporting Affordable Housing. Over the past 15 years we have worked with developers to support building over 2,000 affordable units within our footprint. We also support as part of our mission and purpose as stated in UNNC's bylaws the revitalization of our commercial corridors; beautification and tree planting; and historic preservation. We encourage citywide initiatives to be inclusive of all of these objectives. Although the new proposed ED1 regulations for 100% affordable housing projects will help expedite new affordable housing projects, they do not include sufficient considerations for overlay districts including historic districts (HPOZs, California Register and National Register districts), CPIOs (including Character Residential districts) and other specific plans with objective development and design standards. Projects within such overlays should not be eligible for this program. In order to have more open green space and spaces for trees, UNNC is OPPOSED to requests for reductions in required trees, and SUPPORTS the current iteration of the ordinance that allows no more than a 50% reduction in Open Space. Additionally, UNNC OPPOSES the granting of excessive incentives and waivers, which may result in a project that is wildly different than the character of a neighborhood. Since projects with a great number of requests for development incentives and/or waivers from development standards can be approved through normal land use processes, any project requesting more than five development incentives and/or more than one waiver from standards should not be allowed to utilize the ED1 ministerial streamlining processes. It is important to note that UNNC and its stakeholders worked for many years to implement both HPOZs and CPIOs within our footprints – overlays that promised development protections to our communities – and the new Ordinance should not supercede nor damage those years of community review and thoughtful community planning. – DISCUSSION AND ACTION

ii. **Finalize UNNC Resolution re SB 411**, state legislation that may allow UNNC to change its meetings to zoom only, or to continue with in-person meetings with hybrid format. City Council adopted an authorizing motion on 11/1/2023. Now each neighborhood council must vote, which requires 2/3 vote of the entire board in the affirmative (e.g., 16 board members for UNNC). If approved, for teleconferencing meetings, Board member Zoom attendees must be within the City Limits. For in-person meetings, AB 2449 rules apply.

Draft motion:

Move to file a Community Impact Statement (CIS) for Council File 23-1114 and a Board Resolution to authorize the use of teleconferencing for Neighborhood Council meetings, including board meetings and committee meetings, in accordance with the rules established by Senate Bill 411 and the subsequent motion passed by the City Council on November 1, 2023. UNNC will continue to meet in a hybrid format; Executive Officers will meet in person at the public location as is feasible. Other Board members may opt to be in person or to participate via teleconferencing (from a Los Angeles location), so long as less than a full quorum of the Board meets in person. Committee chairs, in consultation with the Executive Committee, may also select to utilize in-person/hybrid or teleconferencing. The special teleconferencing rules available to Los Angeles Neighborhood Councils are necessary for UNNC to utilize because they may provide for increased accessibility and increased community engagement, as well as the health and safety of the participants. The Resolution to be filed as a CIS to notify all Los Angeles City Council members, and copies sent to DONE and BONC. – **DISCUSSION AND ACTION**

Telecommunication Relay Services

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico and the U.S. territories for local and/or long distance calls. TRS providers – generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user. What forms of TRS are available?

There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TIY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service.

Don't hang up! Some people hang up on TRS calls because they think the Communications Assistant (CA) is a telemarketer. If you hear, "Hello. This is the relay service ... " when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.

If you have limitations hearing or speaking a specially-trained CA can relay telephone conversations for all of your calls. In California, dial 711 to reach the California Relay Service (CRS). If you prefer having your calls immediately answered in your mode of communication, dial one of the toll-free modality- and language-specific numbers below. The call will be routed to the CRS provider.

CRS CAs do not participate in the conversation and acquire no benefit from information relayed.
