**MOTION**

Street lighting is both a quality of life and public safety measure, reducing crimes by enhancing night time visibility and making our City safer to navigate after sundown. Over the past ten years, the City has seen increasing incidents of vandalism against its streetlight network which have resulted in widespread outages and extended the average repair time to restore lighting. The Bureau of Street Lighting is responsible for managing the City's network of 223,000 streetlights and has been exploring innovative ways to harden and safeguard the City's street lighting infrastructure in response to the rise in vandalism against streetlights.

In previous reports to the Council, the Bureau of Street Lighting has stated that it is piloting the use of solar-powered streetlights that would reduce the Bureau's need for copper wire and included the use of solar-powered lighting in its ten-year plan to address the increase in streetlight vandalism (C.F. 22-0600-S56). The use of solar-powered lights could reduce the costs to power the City's expansive streetlight network and minimize the impacts of vandalism due to copper wire and power theft, providing more reliability to the network.

Aside from the safety and reliability benefits that solar-powered lighting can provide, they also reduce electricity consumption and would represent significant investments in clean and green technology. As the Bureau of Street Lighting is responding to a backlog of lighting outages, it should explore the possibility of replacing existing lighting with solar-powered lighting when required to conduct repairs to lighting infrastructure in order to maximize opportunities to deploy green technology and eliminate possible inefficiencies.


The Department of Recreation and Parks currently uses solar lighting in various parks and facilities and has been very successful in operations. The Bureau of Street Lighting should consider utilizing similar technology as a long-term replacement to move street lights to all solar, adding to our climate change goals and ensuring reliability not subject to the whims and activities of copper thieves.

I THEREFORE MOVE that the Bureau of Street Lighting be instructed to report on the feasibility of installing solar-powered lighting in streetlights when responding to lighting outages due to copper wire and power theft incidents or other maintenance issues

I FURTHER MOVE that the Bureau of Street Lighting be instructed to report on the feasibility of moving to mandatory solar-powered lighting in streetlights where feasible throughout the City .

An ordinance adding Subsections (f) and (g) to Section 53.15.2 of Article 3, Chapter V of the Los Angeles Municipal Code to provide a temporary moratorium on the issuance of new dog breeding permits until the dog population in the City's animal shelters is reduced and to add a severability clause.

WHEREAS, the City of Los Angeles is experiencing a dire crisis due to the overcrowding of dogs in Department of Animal Services' (Department) animal shelters, consistent with the growing overpopulation in public and private animal shelters nationwide;

WHEREAS, the current dog population in the Department's animal shelters has exceeded kennel capacity for more than a year, necessitating the doubling and tripling of dogs in single kennels and the placement of dogs in temporary hallway crates for up to months at a time, while, at the same time, increasing strain on Department staff;

WHEREAS, current shelter overpopulation is not ideal for the shelter dogs, escalates costs of animal care and control, and poses an increasing threat to public health and safety;

WHEREAS, Los Angeles Municipal Code Section 53.15.2(c) requires the Department to administer a breeding permit program for unsterilized dogs, resulting in the issuance of nearly 2,000 dog breeding permits annually, which contributes to the overpopulation of dogs in the Department's animal shelters; and

WHEREAS, a temporary moratorium on the issuance of new dog breeding permits during periods of shelter overpopulation will help reduce the population of dogs and greatly benefit the welfare of dogs in the Department's animal shelters.

NOW, THEREFORE,

**THE PEOPLE OF THE CITY OF LOS  
ANGELES DO ORDAIN AS FOLLOWS:**

Section 1. Subsection (f) is added to Section 53.15.2 of Article 3, Chapter V of the Los Angeles Municipal Code to read as follows:

(0 Temporary Moratorium on the Issuance of Dog Breeding Permits.

(1)Initial Moratorium. Notwithstanding the provisions of Subsection (c) of this section, upon the effective date of this subsection, the Department shall not issue any new dog breeding permit until the three-month moving average of the daily inventory count of all dogs at the City's Department-operated

animal shelters is equal to or less than 75 percent of the Department's total dog kennel capacity. Thereafter, this initial moratorium shall be lifted and the Department shall resume issuing dog breeding permits in accordance with the provisions of Subsection (c).

(2) Intermittent Moratorium. If, anytime after the lifting of the initial moratorium in Subsection (f)(1), the three-month moving average of the daily inventory count of all dogs at the City's Department-operated animal shelters is more than 75 percent of the Department's total dog kennel capacity, an intermittent moratorium shall be imposed on the Department dog breeding permit operations for new dog breeding permits. Notwithstanding the provisions of Subsection (c) of this section, upon the imposition of an intermittent moratorium, the Department shall not issue any new dog breeding permit until the threemonth moving average of the daily inventory count of all dogs at the City's Department-operated animal shelters is equal to or less than 75 percent of the Department's total dog kennel capacity. Thereafter, the intermittent moratorium shall be lifted and the Department shall resume issuing dog breeding permits in accordance with the provisions of Subsection (c).

(3) For purposes of this subsection, "dog kennel capacity" shall mean the total number of kennels at the City's Department-operated animal shelters that are designated for the general housing of dogs, and shall not include kennels designated for temporary holding purposes such as for isolation or quarantine.

Sec. 2. Subsection (g) is added to Section 53.15.2 of Article 3, Chapter V of the Los Angeles Municipal Code to read as follows:

(g) Severability. If any provision of this section is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of the remaining provisions of this section. The City Council declares that it would have adopted this section and each and every provision not declared invalid or unconstitutional, without regard to whether any portion of the section would be subsequently declared invalid or unconstitutional

Sec. 3. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.

MOTION (CF 24-04900)

As the Council continues to deliberate any proposed ordinance to streamline affordable housing projects by codifying Executive Directive 1 , it is of utmost importance and in the interest of the public that the City ensure that any streamlined affordable housing development project located in a Historic Preservation Overlay Zone (HPOZ) neighborhood preserve the City's HPOZ Preservation Plans and complement its historic character, inasmuch as all exterior work, including landscaping, alterations, additions, and new construction, is subject to additional Planning Department review.

In a report dated November 28, 2023, the Planning Commission recommended approval of a proposed ordinance (Council File No. 23-0623-SI) to amend the Municipal Code, to establish procedures and performance standards for administrative approval of one hundred percent affordable housing projects.


The proposed ordinance is anticipated to reduce the need for affordable housing projects to request discretionary planning entitlements, and thereby streamline their approval to address the City's housing crisis. The impact of this proposed ordinance as it relates to affordable housing development projects located in the City's 35 adopted local historic districts, also known as HPOZs, is still being debated. Similar to other zoning overlays, HPOZs provide an additional layer of land use regulatory control.

To preserve the character of HPOZ neighborhoods, the Planning Department must ensure that any streamlined one hundred percent affordable housing project is not out of scale, and foremost that it is in compliance with HPOZ Preservation Plans.

I THEREFORE MOVE that the Council instruct the Planning Department, in consultation with the City Attorney, to prepare and present a citywide Interim Control Ordinance (ICO) within 30 days to impose temporary regulations restoring the existing HPOZ discretionary review process on the issuance of permits associated with any demolition, building, use of land, grading, and other applicable permits for the new construction of one-hundred percent affordable housing projects that are currently subject to a ministerial approval process located in a Historic Preservation Overlay Zone (HPOZ) neighborhood, and thereby ensure compliance with HPOZ Preservation Plans.

I FURTHER MOVE that the ICO include an Urgency Clause, making it effective upon publication, and consistent with California Government Code S65858, the ICO shall run for 45 days, with a IQ-month and 15 day extension by Council Resolution, and can be further extended for an additional 1 year, or until the adoption of the appropriate land use regulatory controls have been prepared by the Planning Department, adopted by the Council and become effective, whichever occurs first.

—Van Nuys Plaza (mural to help manage on bank —across from Braude Plaza—saving “Western Wear” which was Van Nuys' first building in 1911 as Bank of Van Nuys

(Hendry has done tour—considering a San Fernando tour (in cooperation with Museum San Fernando Valley)

—Return of the Christmas Angels—The 1950-1980 Bethlehem Star Parade led to 150 6' high Christmas angels posted on VN Bl light standards (can't find more than 3 today)

With it's Millard Sheets mural, a “Van Nuys at 50” diorama of Van Nuys and the Indians to “Van Nuys goes into space”.

—the Whitsett legacy. William p Whitsett. , cofounder of Van Nuys, gave 2 unique buildings, Van Nuys' 10 story building used by CHAMPS, and a high art building on Archwood to oversee the Vons—Butler Brothers shopping center—(now “99 Cent Store—Adrays”).

—Sylvan St corridor (from Kester to Hazeltine). Unique 1920's corridor needing signage For 1926 Library, 1935 Post Office, 1911 Bank of Van Nuys, a 1915“first settlers' house)

—First Christian Science Church—Hamlin St Cedros—beautiful Southern California casual style (theatrical seating)church in need of preservation

—/Cedros trees lining street

Dating from the 1911 founding of Van Nuys, the trees lined the back side of the Whitley Mansion, the baronial home of HJ Whitley who founded Van Nuys.

—Restoring and preserving Sherman Way's palms and pines.  
Planted from 1911 onward to flank the Valley's Great Boulevard, the palms and pines needed a Valley-wide sprucing up—special sidewalks, tree cutouts, signage.

—Turning the 1970's US Post Office into a Van Nuys Mercado/-an open interior place for incubator restaurants for all those judges? Jurors, attorneys, LAPD officers, city planners, city employees all could lunch there.

—Honoring the Tongva ("First Nations") with signage commemorating Pacoima Wash, Tujunga Wash, Cahuenga Pass, Topanga Canyon as named historic sites named for "first citizens".

—The Mulholland Drive Centennial Car Rally". 2024 marks the "centennial of Mulholland Drive"—"What better  
Than all of us, riding in the back of a classic 55 Thunderbird, 65 Mustang, or whatever down Mulholland Drive???"
