Motion to City in Support of Neighborhood-Requested Harbor-Bryan Drainage Project Due to the on-going chronic drainage problem faced by the neighbors around the intersection of Bryan Avenue and Harbor Street, the VNC requests that the City Public Works Department take positive steps to study, finance and physically correct the problem in the 2026-27 budget cycle.

A.MOVE BOARD MEETINGS TO PENMAR REC (Lisa Redmond)

MOTION: The Venice Neighborhood Council moves to hold its monthly Board of Officers regular meetings at the Multipurpose Center located at the Penmar Recreation Center for the remainder of the 2025-26 fiscal year.

DESCRIPTION: The Los Angeles budget crisis has trickled down to Neighborhood Councils and the allotted \$32,000 annual budget for the last several years has now been reduced to \$25,000 for this new fiscal year, which began July 1, 2025. A loss of \$7,000 is palpable and the Venice Neighborhood Council (VNC) needs to assemble immediate costs savings to force the reduced budget to stretch.

MOTION: Conversion of an existing single-family dwelling and ground floor retail to retail only, relocate dwelling unit to a new 366 sq. ft. live/work dwelling unit at rear of property. https://planning.lacity.gov/pdiscaseinfo/search/casenumber/ZA2024-6672-ZV-CDP-SPPC-ADJ-MEL

DESCRIPTION: The Venice Neighborhood Council LUPC recommends that the Venice Neighborhood Council supports the City's approval of a Coastal Development Permit (CDP), a Specific Plan Project Compliance Permit (SPPC) and an Adjustment (ADJ) for the project at 1222 Abbot Kinney for the remodel of an existing single-family dwelling and ground floor retail building to be retail in the front of the property, on the condition that the 311 SF live/work unit is changed to a single-family dwelling (replacing the existing garage at the rear of the property) that is a minimum of 768 SF, the size of the original building (2-story is OK), with 2 long-term and 4 short-term bicycle parking spaces provided (long-term provided in the public right-of-way) and no car parking provided (AB 2097 exemption) (see supporting docs)

17. PARKING, TRANSPORTATION & INFRASTRUCTURE

A.Motion in Support of Westside Regional Alliance of Council's (WRAC's) Position on the MTA's Sepulveda Transit Corridor Project

MOTION: The Venice Neighborhood Council, a member of the Westside Regional Alliance of Councils, supports the proposed underground heavy rail mode through the Sepulveda Pass, described in the DEIR as Alternatives 4, 5 and 6, because that 2 mode will carry significantly more passengers with higher rider capacities, faster speeds, and shorter travel times than the proposed monorail mode

DESCRIPTION: Whereas Metro is planning a rail transit project from the Expo Line north to the San Fernando Valley called the Sepulveda Transit Corridor (STC); and Whereas, while the STC project will not be physically located in Venice, it will offer Venice stakeholders a north-south rail line from the Westside through the Sepulveda Pass, including stops on the UCLA and VA campuses, and connections to other transit routes current and planned; and Whereas Metro has released its Draft Environmental Impact Report (DEIR) for the STC Project and will be deciding soon on both the rail mode (monorail vs heavy rail) and the exact project alignment among the five studied alternatives; and Whereas the Westside Regional Alliance of Councils' (WRAC) Mobility and Transportation Committee (MTC), with participation of the VNC's representative, has studied the STC Project's rail modes and determined that

the heavy rail option is the best choice based on its higher rider capacities, faster speeds, and shorter travel times; and Whereas the Board of WRAC has passed the MTC's motion supporting the heavy rail mode in hope of building a coalition of at least eight member Councils to make this the official WRAC position on the DEIR by the August 30, 2025 deadline; and Whereas in August 2021, WRAC adopted a position supporting an on-campus 1 station at UCLA, and a direct and seamless connection to the Wilshire heavy rail Line subway station at Wilshire and Westwood Boulevards;

18. RULES AND ELECTIONS

A.Required Robert's Rules of Order Training for VNC Board Members

MOTION: The VNC Board approves that all duly elected or appointed Board Members complete the Robert's Rules made simple EmpowerLA – Robert's Rules of Order Training Portal within sixty (60) days of the start of their term. Upon completion, each Board Member must provide the Council with a Certificate of Completion as verification. This training ensures that all members are adequately prepared to participate in and lead meetings in accordance with parliamentary procedures and best practices.

DESCRIPTION: As community leaders, VNC Board Members are expected to uphold the principles of transparency, structure, and procedural fairness. Robert's Rules of Order provides the framework for equitable and efficient governance, and the recently launched EmpowerLA training portal offers an accessible, standardized program to support this learning. Requiring this training will strengthen the integrity and functionality of VNC meetings, foster mutual respect, and improve stakeholder trust in the decision-making process.

Implementation Details:

- As long as is available through EmpowerLA, Board Members must complete the training within 60 days of the start of their term.
- Certificates of completion should be submitted to the Secretary and recorded.
- This requirement applies to all current and future Board Members moving forward.
- A reminder shall be included in onboarding materials for all new Board Members
