<u>#12 WRAC: Request the end of mistreatment of animals and more support for volunteers</u> <u>at Animal Shelters</u>

<u>Motion</u>: The _____ NC/CC strongly supports the sentiments, goals and requests made in the letter from Bel-Air Beverly Crest Neighborhood Council of August 10, 2022 to Mayor Garcetti and Councilmember Koretz concerning the mistreatment of animals at City Shelters.

Dear Mayor Garcetti and Councilmember Koretz,

Like most Angelenos, the Bel Air-Beverly Crest Neighborhood Council was appalled by the reports in the Los Angeles Times of mistreatment of animals in the care of the Department of Animal Services. The Department is understaffed and lacks skilled managerial leadership, and these shortcomings led to a profound breach of moral duty.

It is unfathomable how neither the PAAW Committee nor the Board of Animal Services Commissioners (made up of Mayor Garcetti's appointees) gave any public indication of these problems and left it to a newspaper exposé and the honest words of volunteers to make these conditions known. Smaller news outlets have documented these conditions before, including animal living quarters overrun by rats.

BABCNC has a liaison appointed to coordinate with the Department of Animal Services, but the Department has not communicated with the NC for years even before the pandemic.

Further, volunteers who were indefinitely "suspended" after speaking to the media must be reinstated. Terminating highly-skilled volunteers of long-standing who run shelter programs such as dog playgroups, train other volunteers, and walk the more challenging dogs materially and seriously harms animals in the shelters. Retaliation against employee whistleblowers is illegal, and retaliation against volunteers is wrong and erodes trust in our City's governance structures.

The City's leadership should also consult with shelter volunteers on how to include them in solutions to the shelter system's problems. One option is the formation of an "Animal Services Advisory Committee," with representatives elected by the volunteers.

The animals, volunteers, and taxpayers deserve the ethical treatment that would be provided by a better-run department, and responsibility falls to you and your appointees.

BABCNC will engage with the Department directly. However, responsibility and a plan for action needs to be forthcoming from the Mayor's Office.

<u>#12 WRAC: Support for Position re Ordinance 187427 (Speed Limit Reductions)</u>

<u>Motion:</u> The _____ NC/CC supports the following position in regards to the recent adoption of Ordinance 187427 regarding speed limit reductions (CF <u>21-1223</u>):

1. Supports the action taken by the LA City Council on March 7, 2022 in passing Council File 21-1223 regarding Speed Limit Reductions.

- 2. Supports the efforts to reduce the speed limit by 5 mph on streets that were recently identified for 5 mph speed limit increases.
- 3. Requests that the City Council open a Council File to consider that future speed limit reductions be discussed and planned as neighborhood or regional traffic improvements rather than individual street improvements. These improvements should be coupled with traffic calming measures, such as compact traffic circles/mini roundabouts, restricted turns, curb extensions/bulb-outs, speed humps and tables, and diagonal diverters, half closures, full closures, and median barriers to reduce cut-through traffic.
- 4. Requests that the Council Offices engage the local Westside Councils in ongoing discussions about what additional streets should be considered for speed limit reductions, and establish a method for feedback to be submitted to LADOT.

<u>#12 WRAC: Oppose bicycle and pedestrian improvements on Venice Blvd. until studies are</u> <u>done and traffic calming is installed</u>

<u>Motion</u>: The _____ CC/NC is concerned that removing one vehicle lane in each direction on Venice Blvd. between Inglewood Blvd and National Blvd. will divert traffic onto adjacent local, collector and arterial streets.

Until the DOT conducts modeling studies to predict the volume of vehicular traffic that will be diverted, our Council withholds its support for Phase One of the Venice Blvd Mobility Improvements project (CF 22-0694).

The Councils directly affected are Venice, Mar Vista, Palms and South Robertson. The Councils which may be affected include Del Rey, WLA/ Sawtelle and Westside. <u>WLASNC proposed amendments (J.Ross)</u>: This project will not significantly impact the WLASNC district area because of Venice Blvd's relatively far location, 2 miles away from our district.

The ____ CC/NC supports this project, requests the installation of traffic calming facilities, and diverted traffic shall not be used as an excuse to oppose this project.

Background: The new Venice Blvd Mobility Improvements project has highlighted the importance of project-specific data and studies, so that local and regional impacts of these projects can be identified, discussed and addressed.

Discussions about this new project began in 2020 at the Palms NC with CD5 Transportation Deputy Jay Greenstein and a representative from Streets for All. The WRAC MTC learned of not become in August 2022. This is despite having both CD5 and CD11 Transportation Deputies, Jay Greenstein and Eric Bruins at its June 2022 meeting regarding the Mobility Plan 2035.

LADOT has proposed only one design for this project, which features a car-protected bike lane and a dedicated bus lane on Venice Blvd. A road diet – the removal of one vehicle travel lane in each direction –will create the space to install this bike and bus lane. Phase One would extend the existing 0.8 mile road diet in Mar Vista eastward to a length of 4.0 miles.

LADOT's presentations have not discussed the possible impacts a road diet on vehicle traffic currently traveling on Venice Blvd., including where drivers might redirect their trips due to traffic delays.

In addition, LADOT has not discussed the other bike and bus lanes configurations found in the Los Angeles' Complete Streets Design Guide, many of which would not require a road diet. [This statement cannot be verified, so it may be false. WRAC has not noted a specific cross-section that would work on Venice Blvd., and this is a general statement that cannot be backed up.]

According to Mar Vista, the Great Streets Venice Blvd. pilot project has resulted in drivers diverting their trips off the boulevard and onto local streets during peak travel times. LADOT's one-year evaluation of this project was limited to looking at the impacts on streets north of Venice Blvd to Palms Blvd. Mar Vista criticized it for studying too small of a geographic area.

A more comprehensive way to predict the regional effects is a computer modeling study. Fehr & Peers conducted a study in 2015 as part of the WLA Traffic Improvement and Mitigation Program (WLA TIMP) and Coastal Transit Corridor (CTC) specific plan updates. In Figure 12 - Dynamic Validation Test, a travel lane was removed from Washington Blvd. It shows the regional impact of removing that travel lane, within a 3-mile radius.

During LADOT's outreach meetings in July and September 2022, stakeholders asked about traffic being diverted off Venice Blvd. This question is not addressed in the project's FAQs. Stakeholders also asked how the road diet in downtown Culver City, would impact this Venice Blvd project. This concern is also not addressed in the project's FAQs. Additionally, Transportation Planner Pamela Lee stated that no modeling studies would be conducted for this new project.

#12 WRAC: Bus lane parking violations enforcement by bus cameras

<u>Motion</u>: The <u>NC/CC</u> supports CF21-1224, which implements bus lane parking violations enforcement via bus cameras. City will hire two DOT staff to monitor cameras and issue citations (CF21-1224).

Background:

- 1. Traffic enforcement is for parking violations only (not moving violations, i.e. vehicles using the bus lane).
- 2. Two traffic officers (DOT staff) will be hired to monitor video feeds from bus cameras to issue parking citations for illegally parking in bus lanes during rush hours.

- 3. The LAMC will be updated to allow this video enforcement.
- 4. City Council approved on Nov. 10.
 - a. Transportation Committee approved on Nov. 1.

Findings:

1. Parking violations that block bus lanes reduce the speed and reliability of bus service.

#12 WRAC: Interactive Kiosk Experience program (IKE)

<u>Motion</u>: The <u>NC/CC</u> opposes the IKE (Interactive Kiosk Experience) program, which proposes the installation of 300-500 8-ft. tall video kiosks on sidewalks for traffic/tourism information, which will show commercial advertisements when not in use (CF22-1154).

Streets include Westwood Village, San Vicente, Wilshire, Santa Monica, Pico, Venice, Manchester, Sepulveda and Robertson (40 kiosks in District #11, 50 kiosks in District #5).

The programs has not been adequately vetted prior to City Council consideration, and community outreach has been minimal and inadequate.

The following shall be completed prior to any City consideration or votes:

- 1. A formal environmental review (CEQA) process.
- 2. A competitive procurement (RFP) process.
- 3. Financial analysis that clearly demonstrates that the city will make a profit. Neither the City Administrative Officer (CAO) nor the Chief Legislative Analyst (CLA) has conducted a financial analysis.
- 4. Adoption by motion of Councilmember Bonin's Minority Report, which was presented at the Travel, Tourism and Trade Committee. (Pursuant to Council Rule 69, the Minority Report was submitted for informational purposes only unless by adoption of a motion.) The Minority Report specifies the reports needed prior to consideration of the program.
- 5. An assessment on roadway safety and driver distraction associated with changing digital signage.
- 6. Comprehensive outreach to NC/CCs and the community.

Background:

- 6. The City Trade, Travel and Tourism Committee approved, and the Budget and Finance Committee will consider next (which favors projects like this that generate revenue).
 - a. Councilmember Bonin submitted a minority report to the TTTC Committee that requests further review of the program, and the TTTC must approve that report prior to moving the motion forward to the Council.
- 7. The Public Works Committee reviewed the proposal but did not act. Its agenda noted that two lawsuits were filed after the City approved the STAP program. Because the IKE program relies along the LAMC revisions in the STAP program, the committee did not forward the motion to the Council, and instead requested a report on this issue.
- 8. The City wants to use an RFP from the City of Houston. But Los Angeles should do its own analysis, and allow local businesses to complete (that were not included in the Houston bidding process).
 - a. The City Charter requires local bidding, and this process would violate that tenet.
- 9. The contract will be for 12 years with two extensions of 5 years each (10 years total).

- 10. The digital signs are billed to assist tourists in navigating the city with mobility, cultural and entertainment information. The program originated in the L.A. Tourism and Convention Board in 2015. They entered into a Letter of Intent to contract with IKE Smart Cities (parent company Orange Barrel Media) in 2017 but had a problem.
- 11. The LAMC prohibits advertising structures on the public right-of-way except for transit shelters. This explains why the recently approved new street furniture program (STAP) Mitigated Negative Declaration revised the LAMC to allow advertising structures on the public right-of-way. However, the STAP program did not need this revision because ads on transit shelters are already allowed. The City may have inserted this new text because the IKE program would need it (because advertising kiosks are not exempt like transit shelters are). In fact, the IKE's own documents note that the LAMC must be revised to allow its advertising kiosks in the rights-of-way.

Findings:

- 2. The IKE program will place more distracting digital ads in the public right-of-way. This is the third proposal recently to monetize our sidewalks.
- 3. The cumulative impact of 96 MTA digital billboards along freeways and streets (TCN program), 1,000 bus shelters with digital signs (STAP program), and 300-500 video kiosks on sidewalks will create extensive visual blight and increase vehicle crashes from distracted driving.
- 4. Outreach has been minimal, and the City may be rushing approval prior to the Mayor and other Councilmembers leave office, per the November election.
- 5. Many sidewalks are already narrow, and few are as wide as the sidewalks shown in the promotional photos. Sidewalk signs will displace trees, which are needed to comply with the City's sustainability plans. Sidewalks can be better used for wider access for wheelchairs, more street lamps for better public safety, and the popular outdoor dining program started during the pandemic.
- 6. Signs that will collect cel phone geotracking information are a violation of privacy.
- 7. Bright video signs that shine in residential areas inhibit the ability to sleep and for the brain to heal at night (healthy sleep requires darkness). Insufficient sleep and brain healing produces agitation and aggression, and inhibits the ability to concentration and learn, which harms education, schooling and mental health.
- 8. No provisions for public service messages are included. The I-10 digital billboards south of downtown never display any public service messages.
