The West LA/Sawtelle Neighborhood Council requests that LADOT study the following ranked list of priority intersections for safety improvements, including all-way stop signs, painted crosswalks, and traffic circles.

- Wellesley Ave and Ohio Ave: There is no stop sign or signal on Ohio between Bundy and Centinela (4 blocks). There is high foot traffic across Ohio to businesses and transit along Santa Monica Blvd. A common cycling route requires an unprotected left turn onto Ohio.
- 2) **Wellesley Ave and Idaho Ave:** There is no stop sign or signal on Idaho between Bundy and Centinela (4 blocks). A common cycling route requires an unprotected left turn onto Idaho.
- 3) **Wellesley Ave and Iowa Ave:** There is no stop sign or signal on Iowa between Bundy and Centinela (4 blocks).
- 4) Purdue Ave and Iowa Ave: There is high foot traffic across Iowa to the West LA Farmers' Market, the West Los Angeles Regional Branch Library, the Felicia Mahood Multipurpose Senior Center, and businesses and transit on Santa Monica Blvd. There is a pattern of all-way stops at all similar intersections in the vicinity, which could cause pedestrians to expect cross traffic to stop at this intersection.
- 5) **Sawtelle Blvd and Nebraska Ave:** There's no stop sign/signal on Sawtelle Blvd between Santa Monica Blvd and La Grange (4 blocks), so pedestrians don't have an easy or safe crossing in a half-mile segment. This intersection is adjacent to Nora Sterry Elementary School. It can be difficult for drivers to find a gap in traffic, so they make risky left turns onto Sawtelle Blvd endangering themselves, other drivers, and pedestrians. We acknowledge that recently a signalized pedestrian crossing has been added to this intersection, which is an improvement, but we believe the intersection would most benefit from a stop sign or signal.
- 6) **Beloit Ave and Missouri Ave:** There is a pattern of all-way stops at all similar intersections on Beloit between Santa Monica Blvd and Olympic Blvd, which could cause pedestrians to expect cross traffic to stop at this intersection. members,West LA Sawtelle Neighborhood Council has not received any notices for public

hearings regarding the licensing of cannabis within our boundaries for up to 24 months,

including the latest hearing which took place on March 24th for Application No. 101796.

Guidelines require notification to the neighborhood council and so there is concern regarding
the lack of notice for such a prolonged period of time. Education and compliance with

regulations are important to our residents. We request a list of community liaisons and

contacts for these matters with your office and the operators within our neighborhood council

area. Issues of concern include:

- (i) Ownership/management people would be interested in hearing who owns the store, where are they based, is it part of a larger operation or a solo entrepreneur?
- (ii) Proposed hours of operation is it in line with neighboring and/or sensitive businesses?
- (iii) Security what is the protocol on site?
- (iv) Protection of minors how will minors be protected from entering the property?
- (v) Loitering/cannabis use around the premises are there complaints of people making a purchase and sitting in their cars in the surrounding area to use it?
- (vi) Parking Is there dedicated parking spaces behind the building in compliance with retail guidelines for parking in the city of LA? Is there parking for employees? How are pick-ups handled?

# PUBLIC SAFETY COMMITTEE WESTSIDE REGIONAL ALLIANCE OF COUNCILS WRAC recommended motions:

**TELECONFERENCING:** In conformity with the October 6, 2023 enactment of California Senate Bill 411 (Portanitino) an LA City Council approval on November 1, 2023, The Sawtelle Neighborhood Council will be conducted virtually.

**SB 411 UPDATES:** If a Neighborhood Council has a quorum of board members in a physical location, board members who wish to join the meeting via teleconferencing must adhere to AB 2449 rules and regulations. If a Neighborhood Council does not have a quorum of board members in a physical location, they must adhere to SB 411 rules and regulations.

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the

meeting may be challenged pursuant to Section 54960.1.

The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.

Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.

- (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph, to provide public comment until that timed public comment period has elapsed.
- (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.
- (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

**PAID REPRESENTATIVES:** If you are compensated to monitor, attend, or speak at this meeting, City law may require you to register as a lobbyist and report your activity.
