As a part of our 2025 Grants Challenge, we're excited to share that we're recruiting our fourth cohort of LA2050 Youth Ambassadors.   - A. MOTION: To request CD11 to access Caltrans properties at the intersections and embankments of the 10 Freeway and Barrington Avenue, and Gateway Avenue, for the purpose of conducting regular cleanups. The February 15 issue of the CD11 Update from Councilwoman Traci Park stated that this access was obtained for the Culver Loop Cleanup to assure regular cleanups. The West LA Sawtelle Neighborhood Council requests that cleanups also be conducted at the above intersections. [VIC]

- D. MOTION: To vote on 1770 Sawtelle Blvd. mixed-use: Demolition of 1-story commercial building of 3,400 sf (no residences). New construction of 6-story mixed-use building with 32 apartments (2 very low- and 2 moderate-income). 26 parking spaces. Lot coverage 85%. Requirement to widen Sawetelle Blvd. by 3 ft. and widen Nebraska by 3 ft. 7,700 cy of dirt to be exported (700 truck trips). No protected trees to be removed. Zone C2-1VL (limits height to 3 stories).
  - 1. NC status: PLUM resolution to support project as designed was opposed by the Board in January.
  - 2. Motion (JR, DS): PLUM opposes the project as designed and requests the addition of 1 large-canopy trees planted at grade in deep soil (so roots and branches can grow outward), and combine some studio units to create some larger family units. Passed 7-0-0.

- 4. Entitlement request: Planning Commission. Because of 4 off-menu incentives and 2 waivers, discretionary approval is required.
  - a) State incentive: No parking required. Density bonus of 50%.
- 5. Off-menu incentives:
  - a) Increase height from 3 stories to 6 stories (45 ft to 67 ft).
  - b) Off-menu incentive: Increase FAR from 1.5 to 3.66.
- 6. Off-menu incentive: Decrease rear yard from 18 to 5 ft (houses in rear).
- 7. Off-menu incentive: Decrease north side yard from 9 to 5 ft ().
- 8. Waivers:
  - a) Encroach into building line along Sawtelle and along Nebraska (similar to request to reduce setbacks on 2 sides).
  - b) Keep Nebraska at current width, and not widen by 3 ft.

- E. MOTION: To vote on 2215 S. Wellesley Ave. apartment: Demolition of a 1-story house, and new construction of a 100% affordable co-living apartment of 81 units and 7 stories. No parking is provided. 85% lot coverage. 35,532 sf of building area. 4,087 sf of open space. 21 trees. Zone: R3 (EC).
  - a. Motion (JR, JH): The PLUM committee opposes the project, because (passed 7-0-0):
    - i. The area's infrastructure does not support this high-density project, and city should not approve large projects like this until it verifies that infrastructure can handle it, and
    - ii. The design is orders of magnitude taller and larger in massing than all the houses on the block (7 stories vs. 1-2 stories), and has no buffers nor transitional height to mitigate the extremely large massing (except along the front of Welleslev Ave.).
    - iii. We believe that 100% affordable ED1 projects can be designed with better balance, and at least some parking and greenery.
    - iv. We are concerned that the Palisades fire demonstrates this insufficient water, fire and mobility infrastructure.
    - v. We request a revised design that provides some parking, some buffers to the neighboring houses, better and more varied design of the facade, more open space for the 140 expected tenants, and several trees planted in deep soil with enough room for roots and the branches to expand and grow to full maturity (12x12 ft notches in buildings or front and rear yards).
    - vi. We request that residents of this project be prohibited from receiving parking permits, because the tenants are not supposed to own cars.

TELECONFERENCING: In conformity with the October 6, 2023 enactment of California Senate Bill 411 (Portanitino) an LA City Council approval on November 1, 2023, The Sawtelle Neighborhood Council will be conducted virtually.

SB 411 UPDATES: If a Neighborhood Council has a quorum of board members in a physical location, board members who wish to join the meeting via teleconferencing must adhere to AB 2449 rules and regulations. If a Neighborhood Council does not have a quorum of board members in a physical location, they must adhere to SB 411 rules and regulations.

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting

agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.

Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.

- (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph, to provide public comment until that timed public comment period has elapsed.
- (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.
- (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

PAID REPRESENTATIVES: If you are compensated to monitor, attend, or speak at this meeting, City law may require you to register as a lobbyist and report your activity.
