Title: Mobility Plan 2035 / Mobility Corridors / Pavement Preservation Program / Street Resurfacing / Vehicle Crashes / Traffic Fatalities / Claim Payments / Measure HLA Summary: The WLASNC supports the overarching goals of Council File 24-0173, which will provide the ordinance for Measure HLA-compliant Mobility Plan 2035 implementation and we support most of the Transportation and Public Works Committees' amendments on February 26, 2025. However, we ask that the phrase "made or constructed by the City on a Mobility Plan Street" be replaced by "made or constructed on a City-controlled Mobility Plan Street" in the definition of "Mobility Plan Project" in Sec. 19.211 of Council File 24-0173 in order to ensure all projects on City-owned and maintained streets are Measure HLA-compliant. Otherwise, the City will be required to redesign and reconstruct Metro projects to comply with the Mobility Plan 2035 when doing future maintenance, wasting significant resources in the process. We also ask that Mobility Plan upgrades that mostly involve road striping changes should be required during restriping, such as the implementation of bus lanes and Class II bicycle lanes, as these are ideal opportunities to implement upgrades. We also ask that the appeal process, before civil action, remain optional to achieve a speedy resolution. [A. Caryotakis (4-0-0)]

 SUMMARY:The WLASNC supports full implementation of the Mobility Plan 2035, including
 the Bicycle Enhanced Network (BEN), Bicycle Lane Network (BLN) (eg Barrington), Transit

Enhanced Network (TEN) (eg Pico), Pedestrian Enhanced Districts (PED) (eg Sawtelle Blvd), and Neighborhood Enhanced Network (NEN) (eg Missouri Ave). We commend City Planning for creating a draft "HLA Standard Elements Table" that specifies required and optional elements for each Mobility Plan network and will amend the City's Complete Streets Design Guide. This guidance is an essential step towards improving safety, mobility, sustainability, and livability in Los Angeles. However, there are several flaws with this draft table, and we urge the following changes: 1) State specific traffic volume and speed targets as standard elements for the BEN and NEN, in accordance with the most recent National Association of City Transportation Officials (NACTO) guidance for bicycle boulevards. 2) Include extended leading pedestrian intervals (LPIs), pedestrian recall, hardened daylighting zones, no-turn-on-red, and high-visibility crosswalks as standard elements for PED. 3) Include LPIs (on recall or with bicycle detection) as standard elements for the BLN, BEN, and NEN, allowing cyclists space and time separation from vehicles in accordance with AB 1909 of 2022. 4) Partial and full closure diverters/modal filters should be included as optional interventions for the BEN and NEN. 5) Include raised crossings and raised intersections as optional interventions for the NEN and PED. Submit Community Impact Statement (CIS) in support of Council File: 24-0600-S108. Title: 2024 Budget Recommendation / Transportation / Realigning Positions / Traffic Calming / Safety Improvements / Mobility Plan Neighborhood Network Summary: The WLASNC supports Council File 24-0600-S108, which seeks to create a unit within LADOT dedicated to implementing traffic calming associated with the Neighborhood Enhanced Network (NEN) of the Mobility Plan 2035. All too commonly, local streets in Los Angeles are plagued by dangerously speeding vehicles, inattentive motorists, and high volumes of "rat running" vehicular cut-through traffic. Ultimately, this creates an unsafe and hostile environment in places where families should be able to comfortably and safely stroll. The NEN comprises local streets that will benefit from traffic calming as pedestrian and bicycle safety enhancements, including interventions like curb extensions, mini traffic circles, neckdowns, speed humps, and diverters. These treatments encourage low vehicle speeds and volumes, and force drivers' attention back onto the road. The NEN is therefore essential for improving livability, safety, and mobility for all road users and local residents by calming traffic on local streets. A dedicated unit at LADOT is a worthwhile and necessary investment that will expedite and ultimately provide a superior NEN implementation.

WESTSIDE REGIONAL ALLIANCE OF COUNCILS

MOTION: "WLASNC, a member of the Westside Regional Alliance of Councils (WRAC), opposes SB 677 (Wiener), which mandates further streamlining and automatic approval of certain permits for increased housing development throughout the state, and places all areas within the Very High Fire Hazard Severity Zone (VHFHSZ), including all or parts of Pacific Palisades, Brentwood and Bel Air-Beverly Crest, at risk of public safety, by failing to provide for an unconditional exemption for areas within the VHFHSZ. "We further request that our Councilmembers representing WRAC member councils (Hutt, Park, Raman and/or Yaroslavsky) bring a resolution in City Council forthwith to add opposition to SB 677 to the Council's state legislative priorities for 2025-26."
- 33. <u>MOTION:</u> "Whereas the recent devastating wildfires have left the LA streets and landscape covered with a multitude of toxic chemicals, heavy metals, hazardous materials, ash and

fire debris; "Whereas the recent heavy rainstorms have washed an enormous amount of this toxic material down to our coastline; "Whereas the EPA and FEMA, against strong public opposition, have chosen to use the beach lots along our coast as sorting sites; "Whereas our beaches are now covered with hazardous fire debris and black sludge;

"Whereas no significant water/beach testing information has been released to the public;

"WLASNC, a member of the Westside Regional Alliance of Councils, strongly urges that this environmental catastrophe be taken seriously, with an immediate plan to fund, test, share information, and protect our coastal environment and the millions of people who enjoy it, by City of Los Angeles, City of Santa Monica and Los Angeles County authorities with respective operational control of our beaches in the region, including Dockweiler State Beach, Venice Beach, Santa Monica Beach, Will Rogers State Beach and Topanga Beach. WLASNC further urges that one or more of our Councilmembers who represent WRAC member councils (Hutt, Park, Raman and/or Yaroslavsky) bring a resolution in Council immediately 1) to address this catastrophe on all beaches over which the City has operational control, and 2) to request that the City of Santa Monica and Los Angeles County, respectively, take further, immediate action to address the catastrophe on all beaches over which they have operational control in the region."

TELECONFERENCING: In conformity with the October 6, 2023 enactment of California Senate Bill 411 (Portanitino) an LA City Council approval on November 1, 2023, The Sawtelle Neighborhood Council will be

conducted virtually.

SB 411 UPDATES: If a Neighborhood Council has a quorum of board members in a physical location, board members who wish to join the meeting via teleconferencing must adhere to AB 2449 rules and regulations. If a Neighborhood Council does not have a quorum of board members in a physical location, they must adhere to SB 411 rules and regulations.

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.

Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.

- (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph, to provide public comment until that timed public comment period has elapsed.
- (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.
- (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

PAID REPRESENTATIVES: If you are compensated to monitor, attend, or speak at this meeting, City law may require you to register as a lobbyist and report your activity.
