The Winnetka Neighborhood Council ("WNC") supports the motion within Council File 25-1141. The motion would direct BSS Urban Forestry, with CEMO and the Chief Heat Officer, to develop and report back on a comprehensive citywide tree-replacement strategy focused on climate-resilient, shade-providing species and equitable planting in heat-burdened neighborhoods.

Los Angeles has one of the largest and most biologically diverse urban forests on the planet. The Los Angeles urban forest includes millions of street trees, park trees, and private-property trees that together form Los Angeles' vast and highly visible urban canopy.

The WNC was horrified when, in November 2025, a Winnetka resident was killed by a falling sidewalk tree during their drive home. The City must urgently refocus its attention on supporting and improving its urban forest. Revitalizing our urban forest will improve Los Angeles' climate resilience and atmosphere, but more importantly, it will address worsening safety concerns due to the City's substandard handling of its urban forest.

The motion would direct City officials to produce a comprehensive tree replacement strategy and sets the groundwork for a coordinated, city-wide response that emphasizes scientific assessment, climate adaption, and long-term sustainability. The motion also very importantly calls for an evaluation of existing street tree conditions, recommended drought-tolerant and climate-resilient species, and strategies for prioritizing plantings in the most heat-burdened neighborhoods.

The Winnetka Neighborhood Council ("WNC") supports the motion within Council File 25-1136. The motion would direct the City Administrative Officer, in coordination with the City Attorney, to evaluate and report on the feasibility of reestablishing the Neighborhood Prosecutor Program. The motion addresses the gap in public safety and community responsiveness that emerged after the City Attorney discontinued the Neighborhood Prosecutor Program in 2023. The Neighborhood Prosecutor Program had long served as a vital link between the City Attorney's Office, the Los Angeles Police Department ("LAPD"), and neighborhood residents.

While the Neighborhood Prosecutor Program's replacement, the Community Law Corps Division, is well-intentioned, it is fundamentally flawed. The Corps Division no longer embeds prosecutors within the communities, weakens real-time communication, localized familiarity and expertise, and problem-solving partnership residents rely on. Without a local prosecutorial representative, the City Attorney is less attuned to the chronic nuisance conditions, emerging threats and specific resident safety concerns that have grown worse over the last few years. The WNC submits it is very important to evaluate the feasibility of reinstating the Neighborhood Prosecutor Program, which was an important part of the City's crime-reduction strategy. In light of the service gap that has emerged after the Neighborhood Prosecutor Program was disbanded, a full assessment of restoring the Neighborhood Prosecutor Program supports the goal of Los Angeles benefiting from a proven, effective, and locally responsive law enforcement tool.

RECONSIDERATION AND GRIEVANCE PROCESS

The Board may reconsider and amend its action on items listed on the agenda if that reconsideration takes place immediately following the original action or at the next regular meeting. The Board, on either of these two days, shall: (1) Make a Motion for Reconsideration and, if approved, (2) hear the matter and Take an Action.

If the motion to reconsider an action is to be scheduled at the meeting following the original action, then two items shall be placed on the agenda for that meeting: (1) A Motion for Reconsideration on the described matter and (2) a {Proposed} Action should the motion to reconsider be approved. A Board member who has previously voted on the prevailing side of the original action taken can only make a motion for reconsideration.

If a motion for reconsideration is not made on the date the action was taken, then a Board member on the prevailing side of the action must submit a memorandum to the Secretary identifying the matter to be reconsidered and a brief description of the reason(s) for requesting reconsideration at the next regular meeting. The aforesaid shall all be in compliance with the Brown Act.

PROCESS FOR FILING A GRIEVANCE

Any grievance by a Stakeholder must be submitted in writing to the Secretary of the Board of Directors. The Secretary shall then within no more than 30 days refer the matter to an ad-hoc grievance panel comprised of 3 Stakeholders who are randomly selected by the Council Secretary from a list of Stakeholders who have previously expressed an interest in serving from time to time on such a grievance panel. The Secretary will coordinate a time and a place, not to exceed 10 days, for the panel to meet with the person(s) submitting a grievance and to discuss ways in which the dispute may be resolved.

Thereafter, a panel member shall promptly prepare a written report to be forwarded by the Secretary to the Board to be heard at the next board meeting outlining the panel's collective recommendations for resolving the grievance. The Board of Directors may receive a copy of the panel's report and recommendations prior to any meeting by the Board, but the matter shall not be discussed among the Board members until the matter is heard at the next regular meeting of the Board pursuant to the Ralph M. Brown Act.

This formal grievance process is not intended to apply to Stakeholders who simply disagree with a position or action taken by the Board at one of its meetings. Those grievances can be aired at the Board meetings. This grievance process is intended to address matters involving procedural disputes, e.g., the Board's failure to comply with the Board's Rules or Bylaws, or its failure to comply with the City's Charter, the Plan, local ordinances, state law, and/or federal law.

In the event that a grievance cannot be resolved through this grievance process, the complainant has the right to appeal the matter to the Department of Neighborhood Empowerment for consideration or dispute resolution.
