SUMMARY

On April 8, 2025, the Resolution (Blumenfield – Hernandez) was introduced in support for AB 867 (Lee), which would prohibit the declawing of a cat unless a veterinarian performs the procedure for a medically necessary purpose that benefits the cat's health. The Resolution states that cat declawing is a cruel and unethical surgical procedure that includes the amputation of the first knuckle of each cat's toes, resulting in lifelong disfigurement and pain. The Resolution further states that declawing is prohibited or considered unethical in several countries, including Sweden, Brazil, Germany, Switzerland, the United Kingdom as well as in 15 counties and cities in the United States including New York and Los Angeles.
