- 1. Discussion and planning for the NC booth at the **Grateful Hearts** event in Warner Park on *Sunday, November 9, 2025 9 AM-3 PM* at 21555 Oxnard Street! Rams Village at Warner Center. Parking at 6100 Oxnard Street.
- 2. Motion to approve funding for one or more of the following items in support of Fire Station 84. At the request of Community Services Committee Chairperson Joyce Fletcher, the Fire Station provided the following list of items they need.

- 3. Discussion related to securing a historical designation for the American Legion Hall as it was once a horse stable and then a makeup room at the Warner Brothers Studio in Woodland Hills. - 4. Update on Letter of Recommendation to be sent to Councilmember Blumenfiled related to request for the City Council to adopt an ordinance that includes the following standards that are required for Marijuana Dispensaries.
 - Those standards include forbidding minors from entering the premises, ensuring that each location is not within a 1,000-foot radius of a school or within a 600-foot radius of a public park, public library, religious institution, childcare facility, youth center, alcoholism/ drug abuse recovery or treatment facility, among other restrictions.
