Recommendation

That the Emergency Operations Board, as recommended by the Emergency Preparedness Department, approve and forward to the Mayor for transmittal to the City Council, the revised Homeland Security Needs Assessment Report - December 2004.

Executive Summary

At its March 15, 2004 meeting, the Emergency Operations Board (EOB) approved the last revision of the City of Los Angeles Homeland Security Needs Assessment Report. The original Homeland Security Needs Assessment Report was approved by the EOB in April 2002, updated in January 2003, and revised in March 2004 and December 2004.

Based on new information and approval of several homeland security grants, a reassessment of the Homeland Security Needs was conducted in December 2004. Items funded from grants were removed, new items were added and all were prioritized within each departmental grouping. There are now 87 projects totaling approximately \$128 million in outstanding City-wide homeland security related needs.

As additional information is made available and/or grants are secured, the Emergency Preparedness Department in conjunction with the Mayor's Office of Criminal Justice Planning will continue to update the information and submit updates through the EOB for transmittal to the Mayor and City Council.

If approved, this report will be forwarded to the Mayor for transmittal to the City Council as an information item.
