

PETITION FOR DECERTIFICATION

INSTRUCTIONS:

1. Who May File: An individual employee, a group of employees or their representatives, a qualified employee organization or a joint council of qualified employee organizations may file a petition for decertification pursuant to Section 4.822, f., of the Los Angeles Administrative Code, and the Employee Relations Board Rule 2.
2. Showing of Interest: Written proof that thirty percent (30%) or more of the regular employees in the unit support the decertification petition must accompany the petition. Such proof shall be only by an appropriate authorization statement containing the full printed names, signatures, and employee numbers, signed within three (3) months of the filing of the petition. In addition, a typewritten alphabetical list of the names constituting such showing must be included. Showings of interest not in proper order will not be considered.
3. How to File: (a) File a typewritten original and eight copies of the completed petition together with the showing of interest with the Board, and (b) serve a copy of the petition on both the General Manager Personnel Department and the presently certified representative of the affected unit. Proof of such service must be filed with the Board at the time the petition is filed.
