ADJUST LADOT PARKING RATES AND HOURS FOR OFF-STREET FACILITIES AND

ESTABLISH PARKING RATES AT FREE OFF-STREET FACILITIES SUMMARY

The Los Angeles Department of Transportation (LADOT) manages, operates, and maintains 111 parking facilities across the City, including 28 free facilities. With few exceptions, parking rates at LADOT facilities have not increased in at least 25 years. LADOT seeks to increase rates and/or adjust hours of operations for each facility to keep pace with its operational expenses.

RECOMMENDATIONS

That the Board:

- 1. **AUTHORIZE** LADOT to convert all "free" off-street parking facilities to paid parking facilities with a proposed rate of \$0.50 per hour and extend operating hours as shown in Attachment A.
- 2. **AUTHORIZE** LADOT to increase parking rates for all paid parking and extend operating hours at non-operated facilities (automated using meters, pay stations, and similar equipment) as shown in Attachment B.
- 3. **AUTHORIZE** LADOT to increase rates for all operated (staffed facilities with managed entry and exits) parking facilities and extend operating hours for some of its facilities, as shown in Attachment C.

BACKGROUND

In its Budget Proposal for Fiscal Year (FY) 2025-26 (CF 25-0600), the City Council instructed LADOT to prepare a report to the Board of Transportation Commissioners (BOTC) on fee (rate) assessments at its facilities. This report contains LADOT's recommendations for changes to its parking rates and hours of operation and adheres to City Council's instructions.

Hours of operation and parking rates for LADOT's off-street parking facilities are established by the City's BOTC. Money collected from parking meters and LADOT's off-street public parking facilities is deposited into the Special Parking Revenue Fund (SPRF). The SPRF is used to reimburse the City's General Fund for:

- Purchasing, leasing, installing, repairing, maintaining, and operating parking meters;
- Managing parking meter spaces and collecting receipts;
- Funding expenses related to parking meter operations; and
- Developing and maintaining off-street parking facilities.

LADOT's parking facilities are strategically placed in business districts and near in-demand attractions to help reduce congestion by ensuring that parking is available where needed most. LADOT's Parking Facilities Division (PFD) manages the facilities and aims to ensure that they are well maintained, operating efficiently, and generating appropriate revenues.

Managing the operational efficiency of parking facilities requires parking rate adjustments at regular intervals based on parking demand, market rate analysis, and facility expenses. In the past 25 years, formula based rate adjustments have been made once for 12 facilities. This limited rate increase took place in 2009.

The static parking rate led to net operating losses and the subsidization of several LADOT facilities that would otherwise generate net gains. This made it increasingly challenging to maintain the pace of proper maintenance, including updating equipment. In an inter-departmental memorandum to the City Council's Budget and Finance Committee, LADOT proposed a change in parking rates and operating hours to its off-street parking facilities to offset losses and right-size revenue projections.

Coastal Commission

The Coastal Commission must review changes within the Coastal Zone because these changes could affect beach access, which is within the Coastal Commission's purview. LADOT is asking the BOTC to authorize changes in these locations; however, any rate increases within the Coastal Commission's jurisdiction will be paused until these proposals are reviewed by the Coastal Commission.

Market Rates and Standard Formulas

Market rates are determined based on the mean (the most frequently charged rate) of all available parking facilities by geographic region. The market rate at non-peak hours for parking in the City of Los Angeles is \$5 an hour.

LADOT uses the parking industry standard formula to determine pricing for monthly permits.

DISCUSSION

Discontinue Free Parking

LADOT operates 28 fully subsidized parking facilities. The City purchased most of these facilities more than 50 years ago and never established parking rates for these locations. Several are located in high-traffic areas and experience high usage. LADOT maintains these facilities, incurring ongoing costs that can be offset with a fee per usage. Over a 12-month period (April 2024 to April 2025) the combined maintenance expenses from SPRF for these facilities were \$209,676.67.

Some of these facilities incurred additional expenses outside of SPRF to address damage from encampments. The transition from free to paid parking is a recommended measure to ensure the safe and efficient operation of the facilities and to mitigate the negative impacts of unauthorized use. The current model of free parking inadvertently attracted individuals engaging in illegal activities that compromise the well-being of the community and patrons. Specifically, the establishment of encampments has led to:

- Safety Hazards: Fires, accumulation of debris, and unsanitary conditions.
- Customer Intimidation: Reports of harassment and discomfort from legitimate patrons of the surrounding businesses.

 Community Disruption: Negative impact on the overall perception and safety of the neighborhood.

By implementing a meter rate, LADOT hopes to achieve several key objectives:

- Deterrence of unauthorized use
- Improved enforcement and monitoring
- Improved customer experience
- Liability risk reduction

Generally, subsidized parking imposes hidden costs on consumers and makes a tangible impact on the City's budget. In addition, these facilities reduce the City's revenues from on-street parking since all but two lots are located in parking meter zones. Charging for parking at these facilities is the most efficient use of these properties.

Imposing a minimal rate of \$0.50 per hour is well below the \$5 per hour market rate. Converting these facilities to non-operated lots with the proposed fee will ensure that LADOT can cover its operating costs and generate net revenues. LADOT proposes that all of these facilities operate on a daily basis as described in Attachment A. Proposed daily maximums for each lot are based on maximum 10-hour time limits. Facilities that are currently open 24 hours a day will offer nighttime permits for overnight parking.

Assuming that off-street parking facilities located in parking meter zones will generate the same amount of revenue per space per year as their on-street counterparts, LADOT projects that converting will generate gross revenues of about \$650,000 per year with net revenues of about \$440,000. This estimate does not include the two facilities located outside metered parking zones or the LADOT that are non-operational.

Three LADOT facilities are non-operational, meaning they are fenced off and closed to the public. One additional facility is operated by the Department of Cultural Affairs for staff access to the Nate Holden Performing Arts Center. LADOT asks that these facilities be authorized for conversion to paid parking should these facilities reopen in the future.

All of the parking facilities will operate daily from either from 7:00 am or 8:00 am to 9:00 pm (standard hours for non-operated lots), except where specified in Attachment A. These proposed adjustments to the operating hours and closure times are designed to better serve the needs of surrounding businesses, enhance enforcement capabilities, and further mitigate the risks associated with unauthorized use.

Non-Operated Facilities

LADOT operates 54 non-operated lots throughout the City. Of those 54 facilities, 38 charge rates that are 90% below the \$5.00 per hour market rate - \$0.50 an hour. The remaining 16 facilities charge rates up to \$1 an hour - 80% below market rates.

Applying a parking rate for all non-operated facilities based on the cumulative change in the CPI-U since the year 2010, rounded to the nearest nickel, would increase the City's rates for these facilities by 50 percent as presented in Attachment B. However, the increase would only take the parking rate for LADOT facilities from between 80-90% below market rates to between 70-84% below market rates.

LADOT has no records of approved rate increases at these facilities since the parking rates were established. LADOT chose the year 2010 as its baseline for adjustment to remain below market prices and improve net margins to reduce operating losses.

Because non-operated lots are automated, the operational costs of these facilities are lower than those of operated lots; however, under the current rates, not all facilities are generating enough revenue to cover their maintenance expenses. The net revenues of these facilities over a recent 12-month period (April 24-April 25) were \$1.4 million, with 11 facilities operating with just over \$100,000 in net losses.

Gross revenues for LADOT's operated lots for the same 12 months (April 24-April 25) were \$1.8 million. LADOT does not assume a drop in usage from a rate increase because its facilities will still be the best option for customers looking for below market parking rates. LADOT projects the rate change will result in gross revenues of \$1.8 million (non-operated lots).

To ensure the long-term financial stability of its parking lots, LADOT proposes revising its daily maximum parking fees as noted in Attachment B. Although the number of "free" hours long-term parkers can park will be reduced by three hours, the revised maximum rate will improve cost recovery and maintain a balance between on-street and off-street parking. LADOT also proposes eliminating free parking that exists at a handful of its non-operated lots to be in sync with LADOT's proposal to discontinue free parking at its facilities. For the few non-operated parking lots that offer its users with monthly permits, LADOT determined the rates for its permits using the parking industry's standard formula. In addition to ensuring that LADOT captures the full value for the time each parking space is occupied by charging an hourly rate, LADOT will also gain a simplified rate structure that is easier to manage and operate, improved turnover and parking availability, and pricing consistency and perceived fairness.

With few exceptions, LADOT's non-operated facilities are currently open daily. LADOT proposes to standardize this practice for all its facilities except for locations with prior written agreements for the continuation of community events, such as farmer's markets.

Operated Facilities

Operated facilities are typically parking structures fully staffed with on-site personnel during operating hours and may have part-time security personnel during non-operating hours. They require increased equipment maintenance and/or replacement to ensure optimum performance and revenue capture. Equivalent commercial facilities charge a premium that is above the market rate to cover their costs and ensure net revenues. LADOT recommends initiating more standard rates and increasing them closer to market rates for parking facilities based on the area. These rate increases would allow LADOT to keep pace with the increased labor and equipment costs that may be subject to tariffs. Increasing all the rates closer to standard market rates could generate an estimated \$26,063,561 in gross revenue per year.

In FY 23/24, the most recent fiscal year for which LADOT has a complete data set, 15 of the City's 24 operated facilities operate at a net deficit.

In FY 23/24, gross revenues were \$18.4 million. While net revenues amounted to approximately \$7 million, this revenue falls far short of what is needed to operate and maintain the lots properly. Operated facilities benefit from the issuance of monthly use permits, which create a predictable revenue stream annually. Revenue from monthly permit holders accounted for \$4.1 million in income in FY 23/24.

As shown in Attachment C, LADOT recommends initiating a near market rate for parking facilities based on the following geographic locations: 1. Valley, 2. Downtown, 3. Hollywood, and 4. West Los Angeles. LADOT strives to set its pricing for parking facilities below market rates; however, this is not a sustainable model for parking structures and fully-staffed parking facilities because the Department is not afforded below market operational costs.

A Look Ahead

LADOT is committed to reviewing its fees on a triennial basis to ensure that SPRF revenues are sustainable and that the Department is supplying adequate parking where it is needed the most.

FISCAL IMPACT STATEMENT

There is no impact to the General Fund. Conservatively, all the options presented, if approved, have the potential to generate up to \$6.8 million in total annual gross revenue in FY 25/26 if implemented by January 1, 2026, and an estimated \$29.7 million in FY 26/27.
