## AGENDA BOARD OF FIRE COMMISSIONERS SPECIAL MEETING\* Thursday, December 2, 2021 at 9:00 a.m.

In accordance with Government Code Section 54953, subsections (e)(1) and (e)(3), and in light of the State of Emergency originally proclaimed by the Governor on March 4, 2020 relating to COVID-19 and ongoing concerns that meeting in person would present imminent risks to the health or safety of attendees and/or that the State of Emergency continues to directly impact the ability of members to meet safely in person, the December 2, 2021, meeting of the Board of Fire Commissioners will be conducted entirely via Zoom Webinar teleconference, and telephonically. The meeting will <u>not</u> be conducted at the Fire Commission Meeting Room, City Hall East, Room 1820, 200 North Main Street –  $18^{th}$  Floor, Los Angeles, CA 90012.

Members of the public are invited to address the Board of Fire Commissioners on any item on the agenda. All public comment will be heard at the beginning of the meeting and will be limited to one (1) minute per agenda item, up to two (2) minutes total. Time cannot be ceded to another speaker, and an individual may speak only once during the public comment period. Only those who are in the queue when the chair begins the public comment period will be allowed to speak. The chair may manage the meeting and the public comment time allotted in consultation with the City Attorney.

The President will call for a vote on the Consent Agenda as a whole. The Board's vote will be treated as separate votes for each item considered. Any item may be moved to the Regular Agenda for discussion at the request of a Board member or if a member of the general public submits a request to speak on the subject matter.

DISPOSITION OF ITEMS - Actions of the Board shall become final at the expiration of the next five (5) meeting days of the City Council during which the Council has convened in regular session, unless the Council acts within that time by two-thirds vote to bring the action before it or to waive review of the action.
