- 1. Division 4. Continuing Permits (LAMC, Section 57.04.12C) decrease of approximately 5%.
- 2. Division 5. Non-Continuing Permits and Emergency Inspection (LAMC, Sections 57.05.31 and 57.05.32) decrease of approximately 5% for most fees, except:
  - a. 57.05.31A. 12. Automatic Extinguishing System increase from \$395 to \$600
  - b. 57.05.31A. 18. Drill Oil Well or redrill oil well increase from \$1,738 to \$1,800
  - c. 57.05.31.D. 8. Abandon Oil Well increase from \$790 to \$900
- 3. Miscellaneous Fees LAMC, Sections 57.01.28, 57.01.30, 57.05.14, 57.05.15 and 57.06.15 decrease of approximately 5%.
- 4. Brush Administrative Cost Fee (LAMC Section 57.21.07) increase from \$982 to \$1.026.
