## SUMMARY

The FY 2022 Assistance to Firefighters Grant (AFG) program provides funding for equipment and accessories to assist the Los Angeles Fire Department (LAFD) in life-saving efforts of patients suffering from cardiac arrest. The LAFD submitted an application under the Grant to procure Automatic Chest Compression Devices (ACCDs), one for each ALS rescue ambulance and for each Battalion EMS Captain. This equipment will allow the LAFD to provide uninterrupted and perfect chest compressions on a patient suffering from cardiac arrest even when moving a patient or going up/down a flight of stairs.

On September 8, 2023, the Federal Emergency Management Agency (FEMA) notified the LAFD of an award of funds from the FY 2022 AFG Program to purchase 107 ACCDs and accessories. The total amount to purchase the chest compression devices and accessories is estimated at \$1,851,100. FEMA will fund up to \$1,609,652.17 (85% cost share) on a reimbursement basis. The LAFD will fund \$241,447.83 (15% cost share) through the LAFD Fund 44R, Department 38, Account 3844RA. The grant performance period for the FY 2022 AFG program is September 12, 2023 through September 11, 2025.

## RECOMMENDATIONS

That the board:

1. Approve and transmit the report to the Mayor and City Council for consideration and approval.
2. Request that the City Council, subject to the approval of the Mayor:
  - a. Accept the FY 2022 Assistance to Firefighters Grant in the amount up to \$1,851,100 for the performance period of September 12, 2023 through

September 11, 2025 and any extension of the period of performance granted by FEMA, and authorize the Fire Chief, or designee, to execute any documents or agreements necessary to accept the grant on the City's behalf.

- b. Authorize the Fire Department to expend funds in the amount of \$1,851,100 from the Fire Department's Fund 44R, Department 38, Account 3844RA Kaiser Funds for the purchase of the automatic chest compression devices and accessories in accordance with the FY 2022 Assistance to Firefighters Grant award.
- c. Authorize the Controller to deposit the amount up to \$1,609,652.17 from the FY 2022 Assistance to Firefighters Grant fund reimbursements into Fund 335, Department 38, Account to be determined.
- d. Authorize the Controller to transfer the amount up to \$1,609,652.17 from Fund 335, Department 38, Account to be determined to Fund 44R, Department 38, Account 3844RA.
- e. Authorize the Fire Department to prepare Controller instructions for any technical adjustments, subject to the approval of the CAO, and authorize and instruct the Controller to implement the instructions.

**FISCAL IMPACT**

The \$1,851,100 from Fund 44R, Department 38, Account 3844RA will front fund the expenditures associated with the FY 2022 Assistance to Firefighters Grant program. The FEMA will reimburse the LAFD up to a total of \$1,609,652.17. The required 15% cost share amount will be absorbed by the LAFD's Fund 44R, Department 38, Account 3844RA. Grant disbursements are on a reimbursement basis upon submission of proper documentation.

**Article 1****Assurances, Administrative Requirements, Cost Principles, Representations and Certifications**

As such, it does not apply to tools, equipment, and supplies, such as temporary scaffolding, brought to the construction site and removed at or before the completion of the infrastructure project. Nor does a Buy America preference apply to equipment and furnishings, such as movable chairs, desks, and portable computer equipment, that are used at or within the finished infrastructure project but are not an integral part of the structure or permanently affixed to the infrastructure project. Waivers When necessary, recipients may apply for, and the agency may grant, a waiver from these requirements. Information on the process for requesting a waiver from these requirements is on the website below.
