SUMMARY

The Los Angeles City Fire Department Foundation (LAFDF) has graciously donated a commercial-grade refrigerator and freezer for food storage to Fire Station 41. The purpose of the equipment is to provide safe and sanitary food storage at the fire station. LAFD firefighters work 24-hour shifts and typically cook their meals at the fire station while on-duty. Safe food storage is critical to ensure firefighters remain healthy while on duty. The value of this donation is \$8,827.95.

RECOMMENDATIONS

1. Receive this report for the In-Kind Donation by the Los Angeles Fire Department Foundation for the items listed above, valued at \$8,827.95 to the Los Angeles Fire Department.

FISCAL IMPACT

There is no fiscal impact on the Department's budget from the acceptance of this donation. Donations provide the necessary items to meet the needs of the respective fire stations or administration sections. Replacement or repair of items meeting City specifications and Fire Department business needs may be borne by General Fund, subject to budgetary constraints.
