SUMMARY

The Los Angeles City Fire Department Foundation (LAFDF) has graciously donated new ice machines to Fire Station 72 located in Canoga Park. The purpose of this equipment is to replace the broken unit. Members have been responding to emergencies, including brush fires during record high temperatures and "extreme heat warnings". Staying cool and hydrated is not just a matter of comfort; it is essential for their safety and performance. The value of the donation is \$3,951.84.
