## SUMMARY

The Los Angeles Fire Department Foundation has donated to the Community Liaison Office, via Mr. Jeffrey Neu, a desktop iMac computer valued at \$1,858, copy of invoice attached. This donation will benefit the Department by providing the Public Service Officer (PSO) the ability to create, process, and edit photo/video content for use across all social media platforms. The current desktop computers do not have sufficient capacity or capabilities to perform these tasks, requiring Public Service Officers (PSO) to use their private mobile devices. This donation will improve the PSO's ability to portray the positive image of the LAFD in daily, multimedia communications.

Submitted in accordance with the Los Angeles Administrative Code, Article 12, Sections 5.111.3 and 5.111.4, which provides for the receipt of gifts and bequests of personal property to be utilized by the Fire Department, not exceeding \$5000.00 in market value shall be submitted to the Board of Fire Commissioners for acceptance or rejection.

1. Approve this report and accept the In-Kind Donation from Los Angeles Fire Department Foundation, for the item listed above, valued at \$1,858.00 benefiting the Los Angeles Fire Department.

## FISCAL IMPACT

Replacement or repair of items meeting City specifications and Fire Department business needs may be borne by General Fund, subject to budgetary constraints.
