SUMMARY

The Los Angeles Fire Department (LAFD) entered into an Agreement (C-128005) with the Regents of the University of California (UC Regents), on behalf of the University of California Los Angeles, on August 10, 2016 for an Air-Medical Clinical Care Coordinator (AMCCC). The AMCCC provides aero medical continuing education and training related services that assist air-medical crew members achieve and maintain required competencies and accreditation. Additionally, the AMCCC will conduct trainings, audits and reviews of required reports related to patient care and aero-medical activities.

To ensure sufficient funding is provided for the services to be rendered, the First Amendment is processed to increase the maximum compensation amount of the Agreement from \$65,000 to \$115,000. This contract is funded by the County of Los Angeles through Measure B so the increased contract amount will have no impact on the General Fund

RECOMMENDATIONS

That the Board:

Approve, and transmit to the Mayor in accordance with Executive Directive 3, the First Amendment with the Regents of the University of California, for services of an Air-Medical Clinical Care Coordinator.

FIRST AMENDMENT TO AGREEMENT C-128005 BETWEEN THE LOS ANGELES FIRE DEPARTMENT AND THE REGENTS OF THE UNIVERSITY OF CALIFORNIA FOR AIR-MEDICAL CLINICAL CARE COORDINATOR SERVICES

THIS FIRST AMENDMENT is entered into by and between the City of Los Angeles, a municipal corporation ("CITY"), acting by and through its Fire Department, an emergency medical services provider ("LAFD") and The Regents of the University of California, a constitutional corporation, on behalf of the University of California Los Angeles, UCLA Center for Prehospital Care ("UCLA") is entered into with reference to the following:

- 1. The LAFD desires an Air-Medical Clinical Care Coordinator ("AMCCC") to be responsible for development, presentation and/or oversight of all initial and recurrent continuing education ("CE") training for air-medical crew members to achieve and maintain required competencies and accreditation.
- 2. UCLA employs educators ("UCLA Educators") who can provide services of the AMCCC as set forth herein.
- 3. The parties entered into Agreement C-128005, on August 10, 2016, wherein UCLA agreed to provide professional and specialized technical services for the LAFD.
- 4. The LAFD desires in this First Amendment to increase the maximum compensation amount for the first year of this Agreement by \$50,000, which increases the maximum compensation from \$65,000 to \$115,000.

NOW, THEREFORE, in consideration of the premises, representations, covenants and agreements set forth herein, the Parties represent, covenant and agree to amend Agreement C-128005 as follows:

Section D, <u>LAFD's RIGHTS AND RESPONSIBILITIES</u>, Paragraph 1 is hereby amended in its entirety to read:

1. LAFD will guarantee payment of fees for services provided by the AMCCC not to exceed One-Hundred Fifteen Thousand Dollars (\$115,000) for the first year of service, Sixty-Six Thousand Nine Hundred and Fifty Dollars (\$66,950) for the second year of service, and Sixty-Eight Thousand Nine Hundred and Fifty-Eight Dollars and Fifty Cents (\$68,958.50) for the third year of service.

Section H.1, Payment for Services, Paragraph 1 is hereby amended to read:

The cost of the services is not to exceed One-Hundred Fifteen Thousand Dollars (\$115,000) for the first year of this Agreement. UCLA shall send an itemized monthly invoice in an amount of \$4,166.67 for any ratified services prior to the execution of the Agreement and \$5,416.67 in the first year of service of the Agreement.

Except as herein amended, all other terms and conditions of this AGREEMENT shall remain unchanged.
